

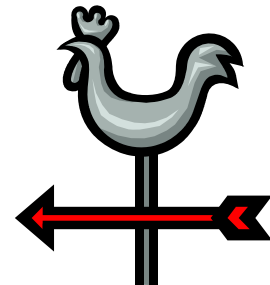

Market Manager will be in the park to direct you to your booth space. Business must bring own booth set-up, e.g. tables, chairs, canopy.
