Doors will open and registration will start at 5:30 PM, and the meeting will start promptly at 6:00PM. Light refreshments will be served. Guests are welcomed to attend, however **only eligible members of the County Council will be able to take part in the voting process**.

The following individuals within Ocean County will be eligible to vote: Municipal Republican Club Presidents (with a weighted vote), Municipal Republican Committee Chairs, Republican Mayors, one (1) designated Republican member of each municipal governing body (if applicable), all present and former County and State elected officials that reside in Ocean County, State Committeeman and State Committeewoman, County Chairman and Vice Chairwoman, County Council President, County Finance Chairman, Treasurer of County Republican Finance and presidents of any other County Republican Organizations recognized by this Council.

Eligible voting members will be voting to endorse candidates for the offices of: House of Representatives (2nd, 3rd, and 4th Congressional Districts), Ocean County Sheriff, and Ocean County Freeholder (two seats).

Please remember Republican Clubs need to be current on their dues before the Convention officially convenes. A check for \$25.00 can be made payable to the Ocean County Republican Finance Committee.

Republican Party Authorization Forms are available from County Council President Jack Kelly. Please remember to bring a letter from your club president listing all endorsed candidates from your municipality. The letter should also request the use of the county line and slogan: Regular Republican Organization of Ocean County. The Party Authorization Form cannot be given without this club letter. The form is to be submitted, along with the Request for Position on Ballot form and petition for local candidates to your Municipal Clerk.
