## **MODELS OF DAYTON FASHION WEEK**

As a registered, selected, and participating (showcasing for a designer) model of Dayton Fashion Week I agree and acknowledge that I will be held accountable for my actions and will also assume any financial liability that should result from a designer's garments becoming damaged by not following the below policies and procedures:

### **REGISTRATION:**

1. ALL REGISTERING MODELS OF DAYTON FASHION WEEK MUST BRING PROOF OF AGE TO THE AUDITION.
2. IF YOU ARE UNDER THE AGE OF 18, YOUR PARENT/GUARDIAN MUST REGISTER YOU DURING THE AUDITION. THERE WILL BE NO EXCEPTIONS.
3. Models of Dayton Fashion Week can be as young as 15 years of age.
4. As a potential model of Dayton Fashion Week I understand that my email must be kept current at all times and that following directions is a key component for participating in this event.
5. As a potential model of Dayton Fashion Week I understand that all models must be 5' 8", must walk STRAIGHT RUNWAY.
6. Female models of Dayton Fashion Week must be between a size zero (0) and a size 12. If larger sizes are needed, that information will be posted on the website.
7. If selected as a model of Dayton Fashion Week, I will be participating on a voluntary basis, unless otherwise stated in writing on official Dayton Fashion Week company letterhead.
8. As a model representing Dayton Fashion Week I promise to handle myself in a respectful, courteous, and professional manner at all times.

### **KEEPING TRACK OF PARTICIPATION HOURS:**

9. If I am a high school student, I or my guardian/parent will assume the responsibility of keeping an accurate track of my hours from the original audition until the last day of Dayton Fashion Week. Community Service Hours include time at the audition, designer fittings, and showcasing during Dayton Fashion Week.
10. If I am a high school student, I or my guardian/parent will make the necessary preparations to get the proper documentation to Dayton Fashion Week for completion for proper credit hour

### **SAVING THE DATES:**

11. If, I am selected to participate in Dayton Fashion Week I must be available to attend both designer fittings. The date, time and location will be distributed at a later date.
12. I have arranged my schedule so that I may be present at both designer fittings that are scheduled.
13. I also understand that if I do not attend both fittings scheduled no special consideration will be made for me to meet with any missed designer(s).

### **DESIGNER SELECTION:**

14. I further understand that if I am not selected by any designer is not the fault of any team member of Dayton Fashion Week, but I will categorize me not getting selected as not fitting the designer's vision for his/her collection.
15. I also understand that I have no say or voice in who a designer selects as representation for their collection.
16. I further understand that designers have their own vision and whomever he/she selects is the final decision.
17. I will not approach a designer during any of the fittings or during the scheduled days of Dayton Fashion Week and ask or inquire about walking for a designer.
18. I understand that if I am caught asking a designer for garments to wear (unless advised by an Executive Producer of Dayton Fashion Week) or if a designer mentions my action(s) to a team member of Dayton Fashion Week I will be asked to leave and I will be removed from the event, Dayton Fashion Week.

19. I understand that I must take full responsibility and care when trying on a designer's garment.

**PRODUCTION:**

20. As a participating model of Dayton Fashion Week, I understand that hair and make-up services will be provided for us.

21. I further understand that no models hair will be cut, colored, or have glue applied to any of the hair follicles during Dayton Fashion Week.

22. As a participating model of Dayton Fashion Week, I understand that I have no voice in how my make-up or hair styling should be created.

23. I understand that if I am heard complaining about the hair or make-up styling as it relates to my personal being, I will be asked to leave the production area and will not be allowed to participate in Dayton Fashion Week.

24. If this happens, both the designer and the production team will be properly notified and I will be replaced by another model for that day or possibly for the remainder of the event. That decision will come from the Executive Producers.

25. I understand that for every day that I participate in Dayton Fashion Week, my hair must be clean and free of all oils, hair sprays, holding sprays, moisturizing lotions, etc. Hair must be in a clean and dry state.

26. I understand that I must not flat iron, curl hair with a curling iron/wand, or apply any heated hair appliance to my hair on the day that I am scheduled to participate as a model.

27. I further understand that if I perform any of the steps listed in numbers 17 and 18, I will be asked to leave the production and will be replaced in a designer's collection by another model. I could be replaced for that day or possible for the remainder of the event. That decision will come from the Executive Producers.

I understand that ALL models attending the model audition must bring with them this page to show that the registering model or registering model with guardian/parent. If this form is not received at the time of submission, I will not be able to participate in the audition.

By signing this form (whether model or model and parent/guardian) I also stated that I will follow the guidelines that are set forth for Dayton Fashion Week, as stated in the Model Registration packet.
