Attorney Cecil J. Thomas***

Cecil J. Thomas has been a staff attorney at Greater Hartford Legal Aid, Inc. (GHLA) since 2006. During this time, he has represented hundreds of clients in housing, benefits, employment, and family matters. He has handled appeals and an amicus curiae brief before the Connecticut Appellate Court, and has appeared before a number of different courts and administrative forums. Cecil has been a member of the board of directors of the South Asian Bar Association of Connecticut (SABAC) since 2007, and served as president of SABAC in 2008 and from 2010-12. Cecil was a recipient of the 2008 Connecticut Supreme Court Law Day Award for participating in efforts to improve diversity in Connecticut's courts. He also serves on the board of the University of Connecticut School of Law Alumni Association. Cecil received his Juris Doctor from the University of Connecticut School of Law in 2006.

Elizabeth G. Shluger, Executive Director,
Hartford Marathon Foundation***

Beth Shluger is founder, CEO and Executive Director of the Hartford Marathon Foundation. Annually, HMF motivates 60,000 people to live more active and healthy lives. Each year, it hosts more than 50 runs and triathlons throughout Connecticut, generating \$51 million in business across the state, raising more than \$4 million for charity. It is best known for the ING Hartford Marathon which draws 17,000 participants. Most recently, HMF produced the Sandy Hook Run for the Families with 15,000 participants and over \$450,000 donated to Newtown. For many years Beth and her husband Judge Kenneth Shluger have donated their time and expertise to the Hartford County Bar Foundation's Joseph J. Cassidy Memorial 5K Road Race, Kids' Run & Family Walk, which this year is scheduled for May 4.
