Consultation Launched on El Service Quality Review

Ministers Duclos and Mihychuk have tasked their Parliamentary Secretaries Terry Duguid and Rodger Cuzner, as well as MP Remi Masse with leading a nationwide consultation process with key stakeholders and the public on improving EI services through call centres, online and Service Canada offices. The review is focused on three areas: 1. Streamlining applications, 2. Reducing wait times, 3. Reducing administrative burden for employers. Commissioners are taking part, sitting in on consultations and offering advice and input to the Review. CEIC Starting EI Rate-Setting for 2017

The change this year is that the CEIC is setting the EI rate, as well as the annual maximum insurable earnings and the premium reductions. The Chief Actuary engaged by CEIC will be working with the new seven-year breakeven, smoothing mechanism. Outside of rate-setting, but important to it, is the question of applicable tax credits. As the work proceeds throughout the summer, to the announcement in mid-September, your Commissioner will appreciate having the benefit of your views. Please indicate your interest in participating in a meeting concerning the state of EI finances and rate-setting.
