The Vice President will be an integral part of a small team of experienced investment professionals building a dynamic early stage company and they will play a critical role in shaping VestedWorld's future.
- Responsibilities:**
- Identify and develop attractive investment opportunities for VestedWorld through market research, networking, calling on referral sources, and active prospecting in target countries with a designated number of closings each year.
 - Build relationships with potential co-investment partners, third party advisors and other stakeholders in target countries.
 - Conduct on-site due diligence on prospective investees, write detailed screening and investment memoranda, identify key areas where the prospective investees will need post-investment support, and present deals to Investment Committee for approval.

- Coordinate and structure exit opportunities; sourcing strategic and financial buyers.
