With three years as HSA Board 2nd Vice President and nine years as a parent to three Lafayette students (one with two more years to go), I decided to transition off the HSA to enable fresh long-term leadership, but then was motivated to apply my accumulated knowledge and perspective through the LSAT. My combination of budget, policy, and operational involvement with Lafayette and DCPS, institutional knowledge, and parent experiences in all seven Lafayette grade levels can offer substantive insights for LSAT advisory tasks.

With regard to LSAT input on school resource allocation, budget decisions, curriculum, and staffing, my HSA VP responsibilities included contract, legal, and compliance issues, as well as executive officer functions for initial budget development; in both roles, I focused on changes intended to strengthen spending justifications and performance metrics that demonstrate links between funding efforts and scholastic needs. For example, activities included supporting launch the pilot Lafayette Enrichment Program with project definition / policies and legal agreements; completing shifts of HSA-funded activities to independent contract status reducing HSA costs and liability while aligning with school interests; advancing performance assessment or evaluation standards for contract services; and increasing spending accountability. I also participated in HSA policy and funding debates and decisions around augmenting options encompassing science, language, recess, music, and mindfulness. Finally, I served as HSA co-liaison to and on a core working group of Lafayette parents that addressed DCPS school boundary revision proposals, contributing to and executing on messaging, coordination, and direct outreach.

While I considered shifting HSA volunteer time outside of Lafayette, I felt my experience would be useful continuity during a bridge year for topics such as DCPS reconsideration of its student assessment practices; spending and use decisions related to new school facilities; review of curriculum changes like World Language and artist-in-residence; return on increased expenditures for central administrative staff, science resources, and instructional coach; expansion of in-school and after-school enrichment options; and impact of Fair Funding Act formula implementation. Having familiarity with most of these topics and nearly a decade of historical context, I can make a particular contribution in representing Lafayette parent views on academic, student, and community priorities.
