- **NSF – Session 1: Applied Education and Broader Impact Design**

Aug. 18

- **NIH – Session 1: Introduction to NIH Tools and Resources**

Sept. 29

This workshop will focus on valuable tools and resources for preparing NIH proposals. Alice Miehl, Ph.D., will cover topics such as: identifying NIH funding opportunities, choosing the right study section and institute/center, NIH Reporter, Federal Reporter and cover letter format. Dr. Miehl holds a Ph.D. in English and, as a Grant Facilitator at FAU, edits investigator proposals and provides advice on argumentation. She has edited over one hundred proposals that were ultimately submitted to a range of federal, state and foundation sponsors. [RSVP here.](#)

- **NIH – Session 2: Uncovering Hidden Pearls in Your NIH Grantwriting**

This workshop will expand on basic NIH grantwriting guidelines and information by providing less well-known nuggets of information to help investigators write a compelling NIH application. Dr. Linda Weglicki is a Professor and Associate Dean of Research and Scholarship in the Christine E. Lynn College of Nursing. Prior to joining FAU, Dr. Weglicki was Chief of the Office of Extramural Programs, Division of Extramural Science Programs at the National Institute of Nursing Research at the NIH. She also served as a Program Officer and managed a grant research portfolio in Health Promotion of Women, Children, and Families. In her roles at NIH/NINR, Dr. Weglicki worked closely with the Offices of Review and Grants Management, giving her a broad perspective of grantsmanship-related activities. [RSVP here.](#)

- **NIH – Session 3: The NIH Review Process**

Daniel Flynn, Ph.D., will provide an “insider’s” look into the NIH review process. Dr. Flynn is FAU’s Vice President for Research. He has received more than 20 years of funding from the NIH. Dr. Flynn has served on the Center for Scientific Review’s Cancer Molecular Pathobiology study section, as well as numerous other review panels. - **Applied Grant Writing – Session 1**
Oct. 9

This workshop will provide writing tips for common proposal sections. Investigators will learn how to streamline their proposals, highlight key ideas and strengthen arguments. Since it is an “applied” workshop, participants will be asked to bring a sample of their writing in order for peers to provide feedback. This workshop, facilitated by Alice Miehl, Ph.D., is intended for researchers who have not yet submitted a large federal proposal or who are relatively new to the process.
