Danielle McGuire, PhD

Author, Associate Professor Wayne State University Detroit, MI

Danielle McGuire is an award-winning author and Associate Professor in the History Department at Wayne State University in Detroit, Michigan and she is the recipient of the 2011 Frederick Jackson Turner Award, and the 2011 Lillian Smith Award.

She is the author of At the Dark End of the Street: Black Women, Race, and Resistance – a new History of the Civil Rights Movement from Rosa Parks to the Rise of Black Power. Her dissertation on sexualized racial violence and the African American freedom struggle received the 2008 Lerner

Scott Prize for best dissertation in women's history. Her essay, "It was Like We Were All Raped: Sexualized Violence, Community Mobilization and the African American Freedom Struggle," published in the *Journal of American History* won the A. Elizabeth Taylor Prize for best essay in southern women's history and was reprinted in the Best Essays in American History 2006.

McGuire is a Distinguished Lecturer for the Organization of American Historians and has appeared on National Public Radio, BookTV (CSPAN), CNN, MSNBC.com and dozens of local radio stations throughout the United States and Canada. Her essays have appeared in the *Journal of American History*, on the Huffington Post, TheGrio.com and TheRoot.com. She lives with her husband and two children in metro Detroit.



Elisabeth Corey, MSW

Founder Beating Trauma North Chesterfield, VA

Elisabeth is a survivor of family-controlled child sex trafficking and sex abuse. Her education in social work and her personal experiences as a survivor inform her intimate dialogue about the biological, psychological, social, and spiritual aspects of trauma recovery, which she discusses on her blog at BeatingTrauma.com. She writes about breaking the cycle of abuse through conscious parenting, navigating intimate relationships as a survivor, balancing the memory recovery process with daily life, coping with self-doubt, and overcoming the physical

symptoms of a traumatic childhood. She guides other survivors as they navigate life and parenting with private sessions, workshops, and a forum. She also works with media and organizations through her workshops, writing, and speaking. Follow her on Twitter and Facebook.




Michael Kimmel, PhD

Professor and Author Stony Brook University Stony Brook, NY

Dr. Kimmel is among the leading researchers and writers on men and masculinity in the world today. He is Distinguished Professor of Sociology and Gender Studies at Stony Brook University, where he directs the Center for the Study of Men and Masculinities. Kimmel is the author of more than 20 books, including Manhood in America: A Cultural History (1996), which was hailed as the definitive work in the field.

Kimmel served as an expert witness for the U.S. Department of Justice in the VMI and Citadel cases. He has consulted with all the Ministries for Gender Equality in the Nordic countries, and was the first man to deliver the International Women's Day lecture at the European Parliament, the Council of Europe, the European Commission, and the European Space Agency. Kimmel has lectured at over 300 colleges and universities, and offered presentations at many of the world's leading corporations on engaging men in support of gender equality.

Sgt. Steven Del Negro (Retired) is a 29 year veteran of the Massachusetts State Police and for the last 12 years of his career he was assigned to the Digital Evidence Media Section/ICAC Task Force. Sgt. Del Negro was the Commander for the Internet Crimes Against Children Task Force in Massachusetts in which he provided training to Law Enforcement, Coordinated ICAC investigations provided public awareness presentations and was the state contact for the National Center for Missing and Exploited Children Cybertips. Prior to his last assignment, Mr. Del Negro worked as a member of the Massachusetts State Police Hostage Negotiation Team. In this capacity, he was responsible for negotiating and

investigating barricaded suspects who may cause harm to themselves or others. As a state police Detective for 16 years, he investigated homicides, unattended deaths, rapes, child abuse, child sexual assaults, and other major crimes. Mr. Del Negro has worked with multiple federal, state, and local agency task forces.

He has a BS in Criminal Justice and is a graduate of the FBI National Academy 198th session. He was the former President and First Vice President of the High Technology Crime Investigators Association New England Chapter. He is also a consultant instructor for ICAC Technical Assistants program in ICAC Investigative Techniques, Knoppix, Yahoo undercover techniques, Cybertip manager, Peer to Peer Investigations (Roundup) and TUX4N6. He has presented around the country at several national conferences on Internet investigations and Internet safety and awareness.

Consent in Corrections: What health care professionals need to know about the care of sexual assault victims under the supervision of the Department of Corrections and the Department of Juvenile Justice.

The Prison Rape Elimination Act of 2003, or PREA, is a federal act that set standards for practices to detect, prevent, and respond to sexual abuse in detention facilities. As the Commonwealth of Kentucky has been actively implementing the PREA standards and ensuring service provision for incarcerated survivors, it is important for healthcare professionals to be knowledgeable about what they may encounter when treating this population. During this workshop, a basic overview of the PREA will be provided, as well as interactive case studies and a professional panel, to assist nurses in understanding the law and identifying unique issues surrounding work with this population. Discussion will focus on the complex concept of consent as applied to incarcerated survivors.

This workshop is designed to meet the five-hour training requirement for SANEs and CNEs.

Melissa Gilpin is a registered nurse with more than 25 years of health care experience, primarily in trauma. Melissa is a Veteran, having served 24 years in the Air National Guard and she has been a Sexual Assault Nurse Examiner in Kentucky for 10 years. She accepted the position of Collaboration Specialist for KASAP in March of 2014. This position allows her to work with a team to provide training for nurses seeking to become Sexual Assault Nurse Examiners, (SANEs), and provide technical assistance to Kentucky's 13 Regional Rape Crisis Centers with building and/or sustaining community Sexual Assault Response Teams and Inter-Agency Councils.



Clorissa Novak, MSSW

Clorissa Novak is the PREA Coordinator for the Kentucky Association of Sexual Assault Programs (KASAP). In this role, she provides training and technical assistance on the Prison Rape Elimination Act (PREA), as well as serves as a single point of contact at the agency for individuals in detention. She also engages in coalition building efforts throughout the state to enhance service provision to incarcerated survivors of sexual abuse. Ms. Novak holds a Master of Science in Social Work degree from the University of Louisville. She comes to this work with a background in victim advocacy in the field of interpersonal violence.

Kentucky Coalition Against Domestic Violence, Frankfort, KY




