



## 2015 AIA Cleveland Sand Castle Competition & Volleyball Tournament - VOLLEYBALL TEAM REGISTRATION Saturday, July 18 | Edgewater Beach

AIA Cleveland is going to the beach! Dozens of teams from Cleveland's most prolific Architecture and Design Firms are hitting the beach to determine the royalty of Northeast Ohio's nascent sand castle design-build and beach volleyball industries. All firm personnel, loved ones, and friends are welcome at this family-friendly event, hosted by Cleveland Metroparks. Individuals and firms are welcome to enter multiple teams, but all teams must pre-register and one registration form must be filled out for FOR EACH TEAM.

NOTE: Volleyball registration is limited to 16 teams and will observe first come/first serve (no pun intended) procedures.

## **Competition Rules:**

- 1. Participation fee is \$225 per team and must be paid upon registration.
- Prizes will be awarded to the top three finishers: First Place (\$450), Second Place (\$350), and Third Place (\$250).
- 3. Teams of all abilities are welcome and all reasonable accommodations will be made to make sure everyone has a good time.
- 4. Tournament is a co-ed, randomly-seeded, double-elimination format, ensuring all teams at least two games.
- 5. At least one member of the team must be a member of AIA Cleveland.
- 6. Teams may be submitted by firm or assembled by individual. All firm employees and spouses are eligible to compete and team members need not be affiliated with just one firm.
- 7. A firm/individual may submit more than one team, but no individual may participate in more than one team.
- 8. Teams may be no larger than eight players or smaller than four, with at least four participants on the court and not more than six.
- 9. There must be at least two women on the court at all times.
- 10. There is no uniform requirement, but color matching is encouraged.
- 11. Matches will feature a best-of-three set format, with all three sets being played in the first two rounds, regardless of outcome. The third set will only be played if necessary thereafter.
- 12. Matches will observe rally scoring; sets 1 & 2 will be played to 25 points (win by two). If sets are split, the victor will be the first team to 15 points in the third set.
- 13. Standard sand beach volleyball rules of play will be observed.
- 14. Matches will be officiated by a crew of experienced referrees who will not tolerate abuse directed at either referees or players. Offending participants will be issued a warning and then disqualified from the tournament with a second violation of this rule.
- 15. Particularly egregious or harmful behavior (major infraction) will result in the immediate disqualification of the player and his/her team without warning.
- 16. Any appeals should be formally lodged with the competition committee, who will make a swift decision. All decisions by the competition committee are final.
- 17. All participants are required to sign a waiver, releasing AIA Cleveland from any liability associated with their engagement in the tournament.
