



2016 AIA BEACH DAY - SAND CASTLE TEAM REGISTRATION Saturday, August 6 | Edgewater Beach

AIA Cleveland is going back to the beach with our second-annual Beach Day! Hundreds of Cleveland designers and community stakeholders will hit the beach to show off their sand castle skills and volleyball game. All are welcome at this family-friendly event, hosted by Cleveland Metroparks. Teams must pre-register for the competition (if your team has more than eight players, please fill out an additional registration form). Sand castle team registration may be limited on the basis of available build sites.

Competition Rules:

- Scholarships will be awarded to the top three finishers: Grand Prize (\$600), Runner-Up (\$500), and Second Runner-Up (\$400). Winners will be determined by a guest jury on the basis of concept, innovation, and execution and by a vote of the public.
- 2. Teams of all abilities are welcome and all reasonable accommodations will be made to ensure enjoyable competition.
- Teams may be submitted by one or more companies, firms, or organizations. All
 employees, ongoing consultants, and spouses are eligible to compete. Team members
 must be affiliated with the organizing company. A company may submit more than
 one team, but no individual may participate on more than one team.
- 4. Individuals without a team may register for the tournament as a "free agent" and will be assigned to a team by event organizers.
- 5. Each team will be provided a 20'x20' plot of beach, five yards of clean building sand, and access to two water pumping locations (lake water), near the competition area.
- Team check-in begins at 7AM, at which point teams are free to setup their build area.
 No sand may be moved until the official start of the build at 8AM. All building must occur between 8AM and 3PM.
- 7. Teams are responsible for providing all of their own formwork, tools, and implements. Buckets, shovels, and masonry tools of all kinds are recommended. All team members and supplies must remain inside the team's designated build area or immediately behind and all must be removed prior to judging at 3PM.
- 8. No adhesives, glues, or foreign substances of any kind are allowed in the construction of the castle. The only non-sand materials that are allowed are found objects.
- 9. No motorized vehicles are allowed beyond designated State Park parking areas.
- 10. A team representative is encouraged to appear at a pre-build meeting.
- 11. The competition will be overseen by a committee of volunteers who will not tolerate abusive language or behavior. Offending participants will be issued a warning and then disqualified from the competition with a second violation of this rule. Particularly egregious or harmful behavior (major infraction) will result in the immediate disqualification of the competitor without warning. Adherence with all Metroparks rules is required.
- 12. Any appeals should be formally lodged with the competition committee, who will make a swift decision. All decisions by the competition committee are final.
- 13. All competitors are required to sign a waiver, releasing AIA Cleveland from any liability associated with their participation in the tournament.
- 14. Teams are responsible for bringing their own beverage coolers and shading devices. No glass containers or alcoholic beverages are allowed on the beach. All teams are responsible for the removal of their shading devices, trash, and recyclables prior to their departure.

RELEASE. INDEMNIFICATION AND HOLD HARMLESS AGREEMENT

In consideration of participating in the AIA SAND CASTLE COMPETITION AND BEACH VOLLEYBALL TOURNAMENT [activity], and for other good and valuable consideration, I hereby agree to release and discharge from liability arising from negligence AIA CLEVELAND [name of insured business] and its owners, directors, officers, employees, agents, volunteers, participants, and all other persons or entities acting for them (hereinafter collectively referred to as "Releasees"), on behalf of myself and my children, parents, heirs, assigns, personal representative and estate, and also agree as follows:

- 1. I acknowledge that <u>SAND CASTLE BUILDING AND BEACH VOLLEYBALL</u> [activity] involve known and unanticipated risks which could result in physical or emotional injury, paralysis, or permanent disability, death, and property damage. Risks include, but are not limited to, <u>SUNBURNS AND HEAT-RELATED ILLNESSES</u>, <u>JOINT/BACK INJURY, LACERATIONS, ETC.</u> [actions that might result in injury]; medical conditions resulting from physical activity; and damaged clothing or other property. I understand such risks simply cannot be eliminated, despite the use of safety equipment, without jeopardizing the essential qualities of the activity.
- 2. I expressly accept and assume all of the risks inherent in this activity or that might have been caused by the negligence of the Releasees. My participation in this activity is purely voluntary and I elect to participate despite the risks. In addition, if at any time I believe that event conditions are unsafe or that I am unable to participate due to physical or medical conditions, then I will immediately discontinue participation.
- 3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless Releasees from any and all claims, demands, or causes of action which are in any way connected with my participation in this activity, or my use of their equipment or facilities, arising from negligence. This release does not apply to claims arising from intentional conduct. Should Releasees or anyone acting on their behalf be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.
- 4. I represent that I have adequate insurance to cover any injury or damage I may suffer or cause while participating in this activity, or else I agree to bear the costs of such injury or damage myself. I further represent that I have no medical or physical condition which could interfere with my safety in this activity, or else I am willing to assume and bear the costs of all risks that may be created, directly or indirectly, by any such condition.
- 5. In the event that I file a lawsuit, I agree to do so solely in the <u>STATE OF OHIO</u>, and I further agree that the substantive law of that state shall apply.
- 6. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.

By signing this document, I agree that if I am hurt or my properly is damaged during my participation in this activity, then I may be found by a court of law to have waived my right to maintain a lawsuit against the parties being released on the basis of any claim for negligence.

I have had sufficient time to read this entire document and, should I choose to do so, consult with legal counsel prior to signing, Also, I understand that this activity might not be made available to me or that the cost to engage in this activity would be significantly greater if I were to choose not to sign this release, and agree that the opportunity to participate at the stated cost in return for the execution of this release is a reasonable bargain. I have read and understood this document and I agree to be bound by its terms.
