## **CURRENT STRUGGLE**

The City of San Francisco has declared its intent to take the property of Community Assembly of God at 355 Ocean Avenue by eminent domain.

We believe this is a travesty should not be allowed to go forward for the following reasons:

• Building low-income housing on this site will exacerbate congestion in this already over-crowded area.

• The mission of this church is to reach the people of San Francisco, and especially those in the Ingleside-Excelsior District. Forcing us to move from this neighborhood at a below market cost, will destroy our ability to remain in this community – a community we have served for over 4 decades – and destroy the positive impact the church has here.

• With this action, the City has made it clear that they do not value churches or freedom of religion. Our church has a long history of creating positive change here, but the City is only interested in meeting the Mayor's goal of increasing low-income housing – no matter the cost to our communities, our families, and our livelihoods.

• The threat of eminent domain is not limited to churches – your home, your business, or any other property could be next!
