#### NEW Events Funding Program - Explore Minnesota Legislative Outcomes

The 2016 Supplemental Budget from the Minnesota Legislature included a total of \$773,000 for a new events funding program which can benefit communities statewide. \$100,000 of this funding is dedicated to the St. Louis County Historical Society for a special project. Additionally, \$300,000 was provided for the promotion of Mille Lacs.
