## Frequently Asked Questions

- Q. What are the CE requirements for the April 30, 2016 and 2017 renewal periods for managing brokers and brokers?
- A. The requirements are as follows:

#### Managing Brokers

**Licensed prior to 2/1/15**: 12 hours of CE (3 hrs. CORE A, 3 hrs. CORE B and 6 hours of elective) plus the 12-hour (2-day) interactive Broker Management Course

**Licensed between 2/1/15 and 2/1/17**: 12 hours of CE (3 hrs. CORE A, 3 hrs. CORE B and 6 hours of elective)

**Licensed after 2/1/17**: no hours due until the 4/30/19 renewal at which time 24 hrs. of CE are needed. (3 hrs. CORE A, 3 hrs. CORE B, 6 hours of elective, plus the 12-hour (2-day) interactive Broker Management Course)

#### **Brokers**

**Licensed before February 1, 2014 and You Renewed in 2014:** 12 hours of CE (3 hrs. CORE A, 3 hrs. CORE B, and 6 hours of elective)

**Licensed between 2/1/14 and 2/1/16:** 30 hours Post License Course. No regular CE needed. **Licensed after 2/1/16:** No hours needed until April 30, 2018 renewal period which will include the 30 hours Post License Coursework.

- Q. If I acquired more CE credit than I needed during the last renewal period can I transfer them to the current renewal period?
- A. No. All classes must be taken within the renewal period.
- Q. Am I restricted to being able to only take 6 hours of CE per year?
- A. No. You may complete your requirements any time during the two-year renewal period.
- Q. I have a managing broker license, can I license down to a broker license?
- A. Governor Pat Quinn recently signed a bill (Senate Bill 1655) that included a provision which will allow a person holding a managing broker license to exchange that license for a broker's license. Contact IDFPR for more information. 1-800-560-6420
- Q. There appears to be a difference in my records that are reflected on the "CE Look-up" on the Illinois Association of REALTORS' website and the IDFPR website. Why is that?
- A. First of all, understand that your local Association does not keep track of your education records. This is the responsibility of the licensee. The IAR and the IDFPR "CE Look-up" links are provided on the landing page of LAMPS for your convenience. Secondly, IAR only tracks the courses taken from their school. (RAR is a branch school of IAR) In other words, if you took a course outside of the IAR/RAR school the transcript would not be reflected on the IAR look-up. IDFPR tracks all courses from *all* schools, however, the updating process is slower. You may not see your transcripts reflected for months. It is highly recommended to keep track of all the classes you took. The "look-up" features on both the IAR site and the IDFPR site is a great way to cross-check with what you are reflecting in your records.
