# **Building Trauma-Informed Schools**

Despite overwhelming evidence that suspensions are not a deterrent for problem behaviors, this disciplinary tool continues to be widely used in schools, particularly with students that have experienced childhood trauma. Attendees will be provided with recommendations for building trauma-informed schools that include infusing therapeutic practices into the school day, utilizing social emotional curricula with all students, adopting a Positive Behavioral Interventions and Supports (PBIS) framework and implementing alternatives to suspension programs.
