## Community Inclusion and the ADA Resources to Fulfill the Promise

Two recent publications provide information on how we can work together to ensure all people with disabilities are fully included and participating members of their communities. One of the publications, times to coincide with the 25th anniversary of the Americans with Disabilities Act (ADA), used five decades of research and the statements of people with disabilities themselves conclude that people with intellectual and developmental disabilities (I/DD) have the best quality of life outcomes when they live in their own homes or with their families, with appropriate supports. The Association of University Centers on Disabilities (AUCD) and the American Association on Intellectual and Developmental Disabilities (AAIDD) released Community Living and Participation for People with Intellectual and Developmental Disabilities: What the Research Tells Us to describe how their organizations "think the next 25 years of the ADA should translate into access, opportunity, and support for people with disabilities," according to their Executive Directors.

The paper includes recommendations for policy makers and advocates to consider that will move us closer to realizing the goals of the ADA - equality of opportunity, full participation, independent living, and economic self-sufficiency for individuals with disabilities.

In another recently released publication, <u>The Case for Inclusion 2015</u>, Louisiana is ranked 24th in the nation on how well State Medicaid programs serve people with I/DD and their families This is a huge improvement from 2007 when the state was ranked 44th in the annual report produced by United Cerebral Palsy. Louisiana is ranked third in the nation in the provision of family support services that keep families together and individuals at home. However, Louisiana is one of nineteen states that do not meet the 80/80 Home and Community Standard of serving at least 80 percent of all resources spent on those with I/DD are for home (less than 7 residents per setting) and community support. There has been vast improvement in this area however, and Louisiana is listed as one of the most improved states.

In addition to state rankings, this publication includes strategies states have used to reduce waiver waiting lists, best practices on transition, and much more.

Both documents will prove valuable in our advocacy efforts to fully realize the promise of the ADA in Louisiana

#### **Invite Support Coordinator to IEP Meetings**

Is your child's Individualized Education Plan (IEP) coordinated with his Plan of Care? A simple step to improve communication and planning is inviting your child's support coordinator to the IEP meeting. Coordination of plans requires communication and communication is best done in-person. If your child has an IEP and receives services through the Office of Citizens with Developmental Disabilities, consider informing your support coordinator of all key meeting dates held with your child's educational team. Support Coordination agencies were informed recently by the Office for Citizens with Developmental Disabilities that participation in IEP meetings is permissible and recommended.

Having your child's support coordinator participate in school-based meetings is a great way to build relationships and ensure accurate and timely information goes into planning the services and supports your child needs. Information provided during school-based meetings may save you time in not having to repeat things later and offers the support coordinator the unique perspective from other professionals working with and caring for your child.

#### Changes Are Coming to Behavioral Health Services

Starting Dec. 1, 2015, Medicaid behavioral health services and substance use treatment will be arranged through one of our five Medicaid Bayou Health Plans. This will include the following services:

- · Outpatient behavioral health and substance use treatments
- Inpatient psychiatric hospital services
- Residential substance use treatment
- Other specialized behavioral health services for individuals meeting set criteria

Home and Community-Based Waiver recipients have received letters giving them the opportunity to choose a Bayou Health Plan for behavioral health services. If a Plan is not chosen, DHH will assign the recipient to one of the five Plans. To choose a Bayou Health Plan for behavioral health services, waiver recipients can call 1-855-BAYOU-4U (1-855-229-6848), enroll on-line at <a href="www.bayouhealth.com">www.bayouhealth.com</a> or fill out the Enrollment Form and mail using the return envelope that was provided with the letter.

Completion of the enrollment form on-line or by mail will not result in a waiver recipient being enrolled for any Medicaid health care services except behavioral health. **Choosing or not choosing a Bayou**Health Plan for behavioral health services will not affect their waiver services.

Some waiver recipients can also "opt in" to Bayou Health for other, physical health services. If they wish to receive other Medicaid health services such as physician or hospital care through a Bayou Health Plan, they must call-in to make the request by phone at 1-855-BAYOU-4U (1-855-229-6848). This also will not affect waiver services. If recipients do not call to opt-in to Bayou Health, they will continue to receive other Medicaid health care services in the same way they do today.

Bayou Health customer service representatives are available at 1-855-BAYOU-4U (1-855-229-6848) to assist members in selecting a Plan. Representatives are available Monday - Friday from 8 a.m. - 5 p.m.

#### **About EarlySteps**

EarlySteps provides services to families with infants and toddlers aged birth to three years (36 months) who have a medical condition likely to result in a developmental delay, or who have developmental delays. Children with delays in cognitive, motor, vision, hearing, communication, social-emotional or adaptive development may be eligible for services. EarlySteps services are designed to improve the family's capacity to enhance their child's development. These services are provided in the child's natural environment, such as the child's home, child care or any other community setting typical for children aged birth to 3 years (36 months).

#### **Services**

Services the EarlySteps program provides include:

- \* Assistive technology
- \* Audiology
- \* Health Services (family education, assistance with other EarlySteps services only)
- \* Medical Services (evaluation only)
- \* Nutrition Services
- \* Occupational Therapy Services
- \* Physical Therapy Services
- \* Psychological Services
- \* Service Coordination
- \* Social Work Services
- \* Special Instruction
- \* Speech Language Pathology
- \* Translation Interpreter Services (foreign language and sign language)
- \* Transportation (to and from an EarlySteps service only)
- \* Vision Services

Effective October 1, 2013 EarlySteps implemented a cost participation system which allows families to share in the cost for some early intervention services. Financial information is gathered during intake for children who are eligible for EarlySteps. Family size and income are use to determine if a family will be required to pay for some services.

#### The EarlySteps Process

Anyone can make an EarlySteps referral. Children can be referred to EarlySteps by contacting the <u>System Point of Entry</u> (SPOE) in their region. Once the <u>SPOE</u> receives the <u>referral</u>, the family will be contacted to begin the eligibility determination process.

## Understanding the Achieving a Better Life Experience (ABLE) Act

The Advocacy Center (AC) is a statewide non-profit agency providing FREE legal services to people with disabilities and seniors.

#### What is an ABLE Account?

An ABLE account is a tax-free account that can be used to save for disability-related expenses for a person who became blind or significantly disabled before age 26.

#### Why is there a need for an ABLE Account?

People with disabilities have many expenses that others do not have. Yet, to qualify for public benefits like SSI, individuals have to remain poor, having no more than \$2,000 in cash savings, retirement funds and other items of significant value. This means that they cannot afford to pay for the extra expenses engendered by their disability. For the first time, eligible individuals will be allowed to establish ABLE savings accounts that will not affect their eligibility for SSI, Medicaid and other public benefits.

#### Who can set up an ABLE account?

ABLE accounts can be created by individuals who became significantly disabled before the age of 26, or by families to support their dependents with disabilities.



### How much can an individual put in an ABLE account?

On an annual basis, an individual can contribute up to \$14,000. (This is equal to the federal gift tax exclusion amount in 2015, and will be adjusted annually for inflation). The total amount in an ABLE account is subject to the Louisiana limit for its education-related Section 529 START accounts, which currently is \$300,000.

## Does an ABLE Account have an impact on other benefits a person with a disability might receive?

If the account grows to more than \$100,000, the beneficiary's SSI benefits will be suspended, but not terminated. The beneficiary would continue to be eligible for Medicaid. It is unclear whether other benefits, e.g. those provided by the State, would be affected if the account grows to more than \$100,000.

#### Which expenses are allowed by ABLE accounts?

Any expense associated with disability-related expenses. These include: education, housing, transportation, employment training and support, health care expenses, financial management and administrative services, assistive technology, personal support services, and other expenses which will be further described in regulations to be promulgated by the U.S. Treasury Department.

#### Can a person with a disability set up more than one ABLE account?

No. Each person is limited to one ABLE account.

#### Where can I go to set up an ABLE account?

States are charged with establishing and operating ABLE accounts before the end of 2015. The Advocacy Center will update this flyer when we a have definitive answer to this question.

#### What are the tax consequences of setting up an ABLE account?

- There is no federal tax on funds held in an ABLE account
- There is no federal tax when funds from the account are used for qualified expenses such as those listed above
- There is no federal tax deduction for someone who contributed to an ABLE account.

#### What happens upon the death of the person for whom an account was set up?

Upon the death of an eligible individual, any amounts remaining in the account must first be paid to any state Medicaid agency that provided assistance from the day the ABLE account was established, not to exceed the cost of care provided. Any excess over the Medicaid reimbursement amount will go to the deceased's estate or to a designated beneficiary and will be subject to income tax, but will not be subject to a penalty.

#### How is an ABLE account different than a special needs or pooled trust?

An ABLE account will provide more choice and control for the beneficiary and family. The cost of establishing an ABLE account will be less than that of establishing a trust. However, for some people, a trust will be preferable than an ABLE account. Determining which option is the most appropriate will depend upon individual circumstances. For many families, the ABLE account will be a significant and viable option in addition to, rather than instead of, a trust account.

NOTE: The committee charged with establishing regulations governing Louisiana ABLE accounts is meeting but has not completed its work. As regulations are promulgated, AC will update this flyer. The purpose of this flyer is to provide general information about ABLE accounts and is not a substitute for legal advice based on individual circumstances.


