Members can connect with others in their community, across the nation and around the world. Members learn about their rights and responsibilities as citizens of the United States of America. The mission of People First of Louisiana is to support people with disabilities to empower themselves in becoming effective decision makers, to gain more independence, and enjoy life as equal citizens of the United States of America. People with disabilities support one another to control their own lives, understand and speak up for their rights, and live up to their responsibilities. "Disability is a natural part of the human experience and in no way diminishes the right of individuals to live independently; enjoy self-determination; make choices, contribute to society, pursue meaningful careers; and enjoy full inclusion and integration in the economic, political, social, cultural, and educational mainstream of American society."

On February 26, 2015, the Northshore Chapter of People First of Louisiana was re-launched with the help of The Arc of GNO Northshore and Northshore Families Helping Families with support from the People First of Louisiana State Chapter. Two of our local self-advocates, Scott Smith and Perry Evans, work together as co-leaders of the chapter. Over 20 members of the group attend monthly meetings and participate in community events. Upcoming meetings are April 13th, May 18th, June 15th, July 20th, August 17th, September 21st, October 19th, November 16th, and December 21st. All meetings are held at 1:00 pm at the Arc of GNO Northshore Community Center at 106 E. 25th Avenue in downtown Covington.

The members of People First of Louisiana Northshore Chapter have been busy promoting the End the R-Word Campaign The pledge is a commitment to support the elimination of the derogatory use of the R-Word from everyday speech and promote the acceptance and inclusion of people with intellectual disabilities. Over 400 signatures on the pledge to end the R-Word were collected at the Kid and Family Expo, the SOAR walk, and Yes We Can community events, in addition to the pledge collection event at the Covington library. Information Alert - Update on Funding for DD Services in the Proposed FY17 State Budget

On March 29th, the Department of Health and Hospitals presented a revised budget to the Appropriations Sub-Committee on Health and Human Services that reflected the revenue raised in the Special Session. Listed below are the changes to services for people with disabilities from the original Executive Budget as presented prior to the Special Session.

What's Funded:

- * ALL waivers
- * Long-Term Personal Care Services
- * OCDD Resource Centers
- * EarlySteps at least enough to avoid cuts to direct services

What's Still Being Cut:

- * Elimination of State Personal Assistance Services (SPAS) in the Office of Aging and Adult Services
- * 10% reduction to Human Services Districts/Authorities this will impact Individual and Family Support and Flexible Family Fund in some regions
- * 40% cut to Families Helping Families Resource Centers
- * The funding to fill over 440 vacant waiver slots for people with developmental disabilities
- * The funding to pay overtime costs for home and community based services

These are the administration's recommendations. The legislature can accept or change them throughout the legislative process.

FY15 Impact of FHF

- FHF Centers are the ONLY "one-stop shops" in Louisiana providing support to ALL individuals with disabilities and their families.
- Over 35,900 contacts were made to local FHF Centers from individuals, families, and professionals who sought and received help.
- 5,982 referrals to services provided
- 5,322 individuals attended 234 trainings on various disability related topics

What Legislators Can Do?

Helping Families (FHF) Centers throughout the

Why Do This?

Every DD Council state dollar goes directly to FHF Centers. The Council's state funds are reduced by approximately \$197,000 (40%) in the Proposed Executive Budget for FY17. Other contracts with the Centers are in jeopardy of similar cuts or elimination.

With these cuts, FHF Centers will no longer be able to maintain the same level of service and will be in jeopardy of closing.

The information, referral, trainings, and peer support provided by FHF Centers are not replicated by ANY other organization in the state, leaving families nowhere else to turn, particularly while waiting years for other services.

FHF Centers are family-directed with a majority of Center staff being parents or family members of children with disabilities or individuals with disabilities. FHF Centers share experience and information from someone "who has been there."

March 24, 2016 Waiver Services Survive This Year Next Year's Fate in the Legislature's Hands

After months of worrying if the waiver services they need to remain in their own home and communities would be eliminated, people with developmental disabilities and their families can take a breath, at least for today. Governor Edwards announced earlier today that the \$70 Million in cuts necessary to address the remaining deficit for the current fiscal year (FY16) would all come from the Department of Health and Hospitals (DHH), but the four waivers for people with developmental disabilities will remain intact.

Unfortunately, the fate of services for people with developmental disabilities next fiscal year (FY17) is still uncertain. When the Governor prepared and presented his Executive Budget for FY17 prior to the Special Session it was based on a \$2.1 Billion shortfall. Funding for the New Opportunities Waiver (NOW) was included, but adequate funding for a long list of other DD services was not. The Governor/Division of Administration will recommend a set of amendments to the Executive Budget to add the revenue raised in the Special Session, but the ultimate decision on what gets funded rests with the legislature. And... the FY17 budget is \$750 Million short.

Since the Special Session ended without a plan to fill the remaining \$750 Million gap for FY17, the Legislature must decide whether to fund the other three DD waivers (Children's Choice, Supports Waiver, ROW), Human Services Districts/Authorities, Families Helping Families Centers, OCDD Resource Centers, EarlySteps, LA Rehabilitation Services, and other programs benefiting people with disabilities. To avoid cuts to any DD services, the legislature would have to take money from somewhere else in the state budget (which is difficult), or the Governor would have to call the legislature into another Special Session to raise additional revenue.

The Council encourages individuals who are concerned about the fate of these vital services to contact their legislators, especially those on the Appropriations Committee, and join the Council's grassroots advocacy network, LaCAN at www.lacanadvocates.org. LaCAN members receive action alerts with updates on the budget situation and opportunities to advocate.

Please note, the Council acknowledges all the individuals and families who are still waiting for waiver services. We began last fall advocating for funding for additional waiver slots, but it soon became evident that our focus needed to shift from expanding to saving the home and community based system from shear elimination. This includes not only waiver services, but Individual and Family Support, Flexible Family Fund, and the other support services that help people endure the eleven year wait for the waiver. Please know that as soon as the system is stabilized, our advocacy efforts will resume to expand waiver services to all those who are waiting.

Governor John Bel Edwards Speaks to Advocates Gathered for Disability Rights Day

Hundreds of LaCAN members from every region of the state gathered at the Capitol on Tuesday, April 5th to participate in the Council's annual Disability Rights Day. Members formed small teams to visit with their regional legislators sharing this year's message, "We're not an OPTION. We're a PRIORITY," along with fact sheets detailing the importance and necessity of funding for various supports and services that people with disabilities need to live in their own homes and be fully participating members of their communities. Many of these services are in jeopardy of cuts and/or elimination in the proposed budget for Fiscal Year 2017 (FY17) due to the budget shortfall.

At noon members converged on the Capitol steps for a rally program which was highlighted by the first-ever appearance of a Louisiana Governor. Governor John Bel Edwards spoke to the crowd, committing to work to protect disability services, and encouraging advocates to continue their work in sharing their stories and educating him and members of the legislature.

Advocates held signs, cheered, and also heard from keynote speaker, Bambi Polotzola, parent advocate and Executive Director of the Governor's Office of Disability Affairs, Representative Frank Hoffman of West Monroe (District 15) and Senator Gerald Boudreaux of Lafayette (District 24).

Later in the day both Regina Barrow of Baton Rouge (District 15) and Representative J. Rogers Pope of Denham Springs (District 71) brought resolutions recognizing the advocacy efforts of the Council and LaCAN and declaring April 5, 2016 to be Disability Rights Day in the State of Louisiana.

2015 Annual Report Available

Each year the Council publishes an Annual Report detailing its activities during the previous year. The 2015 Annual Report and reports from previous years are available to view online. The 2015 Annual Report includes advocacy, capacity building and systems change activities that impacted policy and practice changes in 2015. The report features successful advocacy for additional state general funds to the home and community-based waiver program and appropriate funding structures for school systems. Other highlights include the development of a mentoring program for employment support providers and learning modules for dentists and dental hygienists.



One in Five Families with Children Has at Least One Child with Special Health Care Needs

Did You Know?

- More than one in five families has at least one child with special health care needs – 23% of families.
- Approximately 14.6 million children ages 0 to 17 in the US have special health care needs (SHCN). That's nearly 20% (19.8%).
- The health care needs of these children may be physical, developmental, behavioral or emotional and represent a wide range of conditions including autism, cerebral palsy, developmental delay, intellectual disabilities, depression, learning disabilities, and epilepsy.
- Children with SHCN often have more than one condition and functional difficulties in more than one area that impacts their daily lives, such as breathing, communicating, chronic pain, learning, moving around, behavior, or challenges in making and keeping friends.
- Their families typically experience greater stress, struggling to meet the needs of their child in a maze of multiple and complex systems of care. Many families find that insurance is not adequate, care coordination is ineffective, and referrals are difficult. Families of children with SHCN are less likely to have family-centered health care.

About EarlySteps

EarlySteps provides services to families with infants and toddlers aged birth to three years (36 months) who have a medical condition likely to result in a developmental delay, or who have developmental delays. Children with delays in cognitive, motor, vision, hearing, communication, social-emotional or adaptive development may be eligible for services. EarlySteps services are designed to improve the family's capacity to enhance their child's development. These services are provided in the child's natural environment, such as the child's home, child care or any other community setting typical for children aged birth to 3 years (36 months).

Services

Services the EarlySteps program provides include:

- * Assistive technology
- * Audiology
- * Health Services (family education, assistance with other EarlySteps services only)
- * Medical Services (evaluation only)
- * Nutrition Services
- * Occupational Therapy Services
- * Physical Therapy Services
- * Psychological Services
- * Service Coordination
- * Social Work Services
- * Special Instruction
- * Speech Language Pathology
- * Translation Interpreter Services (foreign language and sign language)
- * Transportation (to and from an EarlySteps service only)
- * Vision Services

Effective October 1, 2013 EarlySteps implemented a cost participation system which allows families to share in the cost for some early intervention services. Financial information is gathered during intake for children who are eligible for EarlySteps. Family size and income are used to determine if a family will be required to pay for some services.

The EarlySteps Process

Anyone can make an EarlySteps referral. Children can be referred to EarlySteps by contacting the <u>System Point of Entry</u> (SPOE) in their region. Once the <u>SPOE</u> receives the <u>referral</u>, the family will be contacted to begin the eligibility determination process.


