

MANDATORY INSURANCE COVERAGE

Certificate of Insurance Required By June 28, 2016

Unless an adequate certificate of insurance is received, exhibitors/concessionaires will not be allowed to move into your booth/outside location. Failure to do so could result in cancellation of your contract.

The Canadian National Exhibition does not carry insurance of any kind on commercial exhibits.

Each exhibitor **MUST** file evidence of the existence of public liability insurance with Exhibition Place in the form of an original insurance certificate or certified copy of a liability policy providing limits of no less than **\$2 MILLION** in respect of each person and/or occurrence.

Any exhibitor sampling or selling **ANY** food product **MUST** file evidence of the existence of public liability insurance with Exhibition Place in the form of an original insurance certificate or certified copy of a liability policy providing limits of no less than **\$5 MILLION** in respect of each person and/or occurrence.

Every exhibitor shall fully indemnify and save harmless the Canadian National Exhibition Association, Board of Governors of Exhibition Place, Maple Leaf Sports and Entertainment and the City of Toronto, from and against all claims and demands, costs, charges and expenses whatever, which it may incur, suffer or be put to by reason of any accident, or death, or any person or property suffering damage injury through or by reason of any such exhibit. All goods brought to the show need to be covered for any misfortunes. The exhibitor is also responsible for any personal injury that occurs as a result of their display and such must have insurance coverage. This can be done by either adding on a rider policy to your existing commercial/residential insurance or obtain a temporary insurance from our official Insurance Broker.

OPTIONS FOR ARRANGING THE REQUIRED INSURANCE:

Option # 1: Contacting your own Broker

Contact your own Insurance Company and request a Certificate of Insurance advising them that the **following requirements must be included in the Certificate of Insurance:**

- Canadian National Exhibition Association, Board of Governors of Exhibition Place, Maple Leaf Sports and Entertainment and City of Toronto **must be listed as additional insured's**.
- **Dates of the show:** August 12 – September 09, 2016 (includes mandatory move in and move out), and list **Booth Numbers for all Booths or Outside Locations** that you occupy must be included on the certificate
- Comprehensive General Liability of \$2,000,000 Bodily Injury and Property Damage Liability subject to a maximum of \$1,000 Deductible
- Comprehensive General Liability of \$5,000,000 Bodily Injury and Property Damage Liability subject to a maximum of \$1,000 Deductible for Food Product Exhibitors
- Bodily Injury and Property Damage Liability subject to a maximum of \$1,000 Deductible
- Products and Completed Operations Liability
- Contingent Employers Liability
- Broad form Property Damage
- Cross Liability Clause +
- Severability of Interest Clause

Option #2: You do not have insurance
