Deadlines – Funded applications may be submitted from July 1 through September 27, 2015, and will be honored on a first come, first served basis. The FabMo TAB Committee may, at its discretion, accept applications received after that date.

Fee is \$60 per table space/\$35 each exhibitor if shared table. Fees are **non-refundable** except in the case of cancellation of the event by FabMo or Palo Alto Elks Lodge.

Exhibit space is a floor area of 6' x 9' (approx.), with a 6' or 8' table and 2 chairs. All spaces are indoors in two adjoining rooms. The FabMo TAB Committee will assign spaces and post a site map/directory. Display height indoors is limited to 5 feet measured from the floor unless approved in advance. Tablecloths will not be provided and are the responsibility of the exhibitor.

Special requirements and requests (wheelchair, electrical outlets, extra chairs, different size table, oversize items, etc.) will be accommodated when possible with advance notice. If you have your own display set-up, it must be approved by the FabMo TAB Committee before October 3. No canopies. The Committee will make every effort to accommodate your set-up, so please contact us if necessary at FabMoTAB@gmail.com.

Shared exhibit space is allowed (and we can help match partners if requested). Each exhibitor must submit a signed Exhibitor Agreement indicating the names of their table mate(s).

FabMo will provide exhibitor nametags for you and your exhibit helpers. Please provide all names to FabMoTAB@gmail.com by **October 20**. Wi-fi will be available.
