Deadlines – Funded applications may be submitted beginning July 1, 2016 and will be honored on a first come, first served basis. Only one space per exhibitor allowed.

Fee is \$75 per table space. Fees are **non-refundable** except in the case of cancellation of the event by FabMo or Palo Alto Elks.

Exhibit space is a floor area of 6' x 9' (approx.), with a 6' or 8' table and 2 chairs. All spaces are indoors in two adjoining rooms. The FabMo TAB Committee will assign spaces and post a site map/directory. Display height will be limited to 5 feet measured from the floor unless approved in advance. Table coverings are NOT provided. FabMo will provide nametags for exhibitors and their helpers. Wi-fi will be available.

Special requirements and requests (wheelchair, electrical outlets, oversize items, etc.) will be accommodated when possible with advance notice. If you have your own display set-up, it must be approved by the FabMo TAB Committee before October 8. No canopies. We will make every effort to accommodate your set-up, so please contact us if necessary at FabMoTAB@gmail.com.

Shared exhibit space is allowed (we can help match partners if requested.) **Each exhibitor must submit a signed Exhibitor Agreement indicating the names of their table mates. All named exhibitors must be present on 10/22/16.**
