ANNEXED TO ARTICLES OF CONTINUANCE OF THE ANTHROPOSOPHICAL SOCIETY IN CANADA, INC.

Additional Provisions

- a. The Corporation shall be carried on without the purpose of gain for its members, and any profits or accretions to the corporation shall be used in furtherance of its purposes.
- b. Directors shall serve without remuneration, and no director shall directly or indirectly receive any profit from his or her position as such, provided that a director may, by resolution of the board of directors, be reimbursed for reasonable expenses incurred in performing his or her duties. A director shall not be prohibited from receiving compensation for services provided to the corporation in another capacity.
- c. The directors may appoint one or more additional directors who shall hold office for a term expiring not later than the close of the next annual general meeting of members, but the total number of directors so appointed may not exceed one-third (1/3) of the number of directors elected at the previous annual general meeting of members.
- d. Except for:
 - i. the required number of votes to remove a director that is provided for in the Act,
 - ii. the election of directors and
 - iii. the submission of a matter to a vote, which shall require only an ordinary resolution.

in each instance where a matter is the subject of a vote at a meeting of the members or a meeting of the board of directors, the matter shall be determined by at least 75% of the votes duly cast on the matter by the persons entitled to vote thereon.
