Role of Treasurer

- Keep financial records for Chapter
- Process reimbursements – pay vouchers
- Make deposits – keep detailed records/submit to DCEF
- Process transfer requests
- Reconcile Oracle statements
- Ensure you are in compliance with IRS requirements
- Provide financial information to Chapter board
- Submit annual budget to DCEF
- Attend Annual Chapter Meeting each fall
