



# Link My License – Additional Licenses

Linking to additional real estate licenses should be limited to the following:

1. Principal Broker (PB)/Broker in Charge (BIC) linking the Entities license if authorized by the entity to do so.
2. Entity linking to the PBs/BICs license is authorized by the principal to do so.

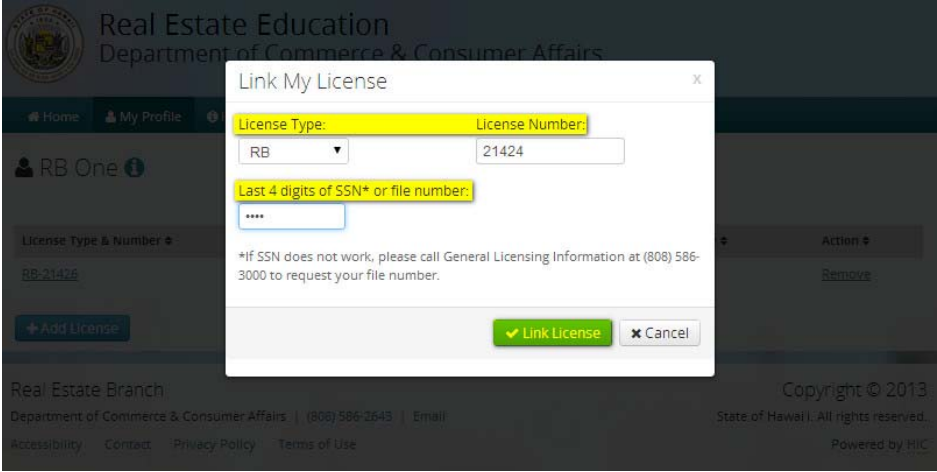
Individual licensees should not link to other individual licensees. The following are examples of licenses that should not be link:

1. Salespersons/Broker Salespersons should not be linked to other salespersons/broker salespersons.
2. Salespersons/Broker Salespersons should not be linked to associating brokerage.
3. PBs should not be linked to associating salespersons/broker salespersons.
