

SAFE ENVIRONMENT

Any individual who volunteers with students at Kennedy Catholic High School needs to take the **Safe Environment Training**. The Archdiocese of Seattle has switched over to the **VIRTUS** program for training and compliance tracking.

If you have taken the **Safe Environment Training** you should have received an email from the Archdiocese of Seattle providing you with your Username and Password to log into your personal profile.

If you are a **New Volunteer** and need to take the **Safe Environment Training**, you will need to go to the **VIRTUS** website at www.virtusonline.org. Once there, you will need to register by selecting **Seattle, WA**, which will place you into the **Archdiocese of Seattle**. Once you have set up your personal account, you can select the day and place you would like to take your **Protecting God's Children for Adults** class training as well, you will need to fill out the **Background Check** information.

Beginner's Guide to Creating a VIRTUS Profile

The Archdiocese of Seattle uses the VIRTUS program along with the VIRTUS database to comply with Safe Environment requirements. Once you have been hired or taken on as a volunteer within the Archdiocese of Seattle you will need to create a profile on VIRTUS. Your profile will allow you to read policies, sign up for Safe Environment courses, and enter background check information (if you qualify for one).

There are a few steps that need to be taken to create a VIRTUS profile. This guide will provide instructions for creating a VIRTUS profile. Although the steps have been broken down into sections, you must finish all of the steps from Sections 1-4 to complete the registration process.

Note: If you qualify for a background check, you will be prompted to enter more information after Section 4. If you do not qualify for a background check, disregard Section 5 of this guide.

SECTION 1: Creating a Username and Password

These steps will help you complete the identification portion of your profile. Make sure all of the information you provide is accurate.

1. **Open** your Internet browser
2. **Navigate** to virtusonline.org
3. **Click** on “Registration” under the sign-in field found on the upper-left hand corner of the webpage (See Figure 1).
4. **Click** on “Begin the Registration Process.”
5. **Choose** “Seattle, WA (Archdiocese)” from the drop-down menu on the next page.
6. **Click** “Select.” You should see the Archdiocese’s code of armor on the next page.
7. **Type** a Username and Password into the correct fields.
Tip: Write down your username and password somewhere secure in case you forget them.
8. **Click** “Continue.”
9. **Type** your personal information into the required fields on the following page.





SECTION 2: Selecting a Location and Function

Once you have finished the identification portion of your profile, you will be able to choose the location(s) where you work or volunteer, as well as choose your function within the Archdiocese of Seattle.

10. **Choose** the location where you work or volunteer from the drop-down menu found on the page after you enter your personal information.
11. **Click** "Continue."
12. If you work or volunteer at multiple locations, **select** "Yes" on the following page. If you DO NOT work or volunteer at multiple locations **select** "No."
13. If you work or volunteer at multiple locations, **repeat** Step 7 until you have selected all of the locations.
14. **Make sure** that all of the locations where you work or volunteer are listed before continuing (See Figure 3).



15. **Select** "No" once all of your locations have been selected (See Figure 3).
16. **Select** your role(s) for the Archdiocese of Seattle from the provided list on the following page. **Note:** You can select more than one option for this step.
17. **Type** your job title or description into the textbox at the bottom of the page (See Figure 4).
18. **Click** "Continue."
19. **Select** the options for Seminarian or CYO coach only if applicable.
20. **Click** "Continue."



SECTION 3: Preliminary SEP Compliancy Requirements

After you have finished the location and function portion of your profile, you will be able to start your Safe Environment Compliance requirements. **Note: you are not in compliance until you have read the SEP Policies, completed a *Protecting God's Children* course, and have had a background check (if you qualify for one).**

21. **Download** the policies on the next page by clicking on the PDF thumbnails below each policy.
22. **Click** the boxes certifying that you have downloaded, read, and understand each policy (See example in Figure 5).

23. **Provide** an electronic signature by typing your name and the date into the correct field beneath the policies.
24. **Click** "Continue."
25. **Select** "Yes" or "No" in response to the background check qualification questions on the following page. **Note: Answer these questions accurately, as this will determine whether or not you qualify for a background check.**


SECTION 4: Signing up for a *Protecting God's Children* course

Once you have read the policies and answered the background check qualification questions, you will be able to sign up for a *Protecting God's Children* class. **Note:** At the time this guide was made, only one class was available. There should be more class options starting this fall.

26. **Select** "No" in response to the question "Have you already attended a VIRTUS Protecting God's Children Session?"

27. **Select** a class from the list on the next page that best suits your needs (See Figure 6).

28. If you DO NOT qualify for a background check, you will be able to **select** "Complete Registration" at the bottom of the page.

30. **Click** on the Trak-1 hyperlink on the next page (See Figure 6).

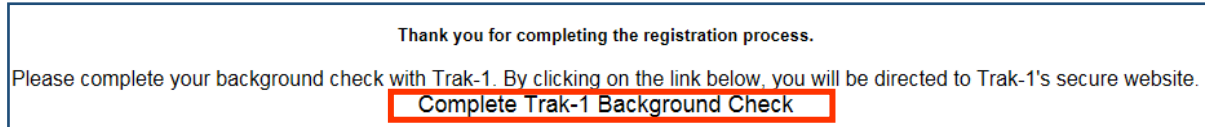
