# **Democratic Voters: Anita Alvarez Survey**

**CHICAGO, IL** - Ogden & Fry, conducted a 3-question poll for **The Illinois Observer** on Tuesday, December 8, for State's Attorney Anita Alvarez' job approval rating among Cook County Democrats with 551 respondents. Respondents were selected by random sampling of likely 2016 Democratic Primary voters. The margin of error for this poll is +/- 4.26% at the 95% confidence interval.

# Do you approve or disapprove of the way Cook County State's Attorney Anita Alvarez is handling her job?

Since the release of the Laquan McDonald shooting video, there have been calls for Cook County State's Attorney Anita Alvarez to resign over her handling of the McDonald case. Do you think Anita Alvarez should resign?

#### **ANALYSIS**

Note: This universe of respondents is limited to Cook County voters who have voted in at least 2 of the last 3 Democratic primaries and never voted Republican. In other words, this poll is Cook County Democrats, not all Cook County voters.

When initially asked about Anita Alvarez' job performance, over 61% of Cook County Democrats approved. When asked if Alvarez should resign in light of the Laquan McDonald case, an equal percentage (61%) also said "yes."

Since the responses of the first two questions seems contradictory, the poll questions and answers, data, and results were double-checked for accuracy. It appears the Laquan McDonald case is so emotionally charged that nearly 40% of respondents who initially approved of State's Attorney Alvarez' performance thought she should resign in light of her handling of the McDonald case.

Democrats slightly prefer Kim Foxx over Alvarez, but 55% remain undecided. It is not good for an incumbent to be trailing an opponent at the beginning of the campaign season.

Expect the Laquan McDonald case to dominate this race.

#### **METHODOLOGY**

Ogden & Fry strives to increase the accuracy of political polling by measuring voters most likely to vote based on voter history. Voting is a socialized behavior with predictable reliability and consistency.

Ogden & Fry maintains a database with 20 years of voting history. For this job-approval survey, voters were randomly selected from voters who voted in at least 2 of the last 3 Democratic Primary elections and never voted Republican.
