ASSOCIATION OF COLLEGES AND SCHOOLS OF ARCHITECTURE (ACSA)

- The Presidents, Presidents-elect, and executives from both organizations met at the NCARB offices to discuss initiatives impacting both organizations including NCARB's integrated path to licensure initiative.

AMERICAN INSTITUTE OF ARCHITECTS (AIA)

- The twice-yearly AIA/NCARB Leadership Summit was hosted by NCARB at its offices in April. Attendees included the Presidents, Presidents-elect, and CEOs of both organizations. Discussion covered updates on organizational initiatives, previews of annual conferences, and priorities for the coming year.

AMERICAN INSTITUTE OF ARCHITECTURE STUDENTS (AIAS)

- The NCARB Board of Directors hosted a joint meeting with the President, Vice President, and Executive Director of the AIAS at its April Board Meeting.

NATIONAL ARCHITECTURAL ACCREDITING BOARD (NAAB)

- Staff and Board leadership prepared for a presentation at the upcoming Canberra Accord meetings in Boston, hosted by the NAAB. Canberra Accord signatories gather annually to discuss their commonalities and approaches regarding accreditation of architectural education programs. NCARB views this group as presenting an opportunity for new mutual recognition agreement discussion.

**Dear Colleagues:**

Let's Go Further! For the past year, NCARB staff have been rallying around this phrase as a way to demonstrate that collaboration is essential to helping our Member Boards and customers achieve their goals. Seeing our work through the

eyes of our colleagues across departmental boundaries is quite revealing—seeing through the eyes of Members and customers is essential. A series of internal staff meetings has resulted in adopting “Let's Go Further” as an organizing tool internally, and as a way of demonstrating our relational focus externally.

In supporting the concept of going further, our staff has also embraced a reinvigorated Values Statement which takes our previous generic list and distills our forward focus into three key words:

- *Open – by transparently sharing our approaches and expertise, we forge dynamic partnerships.*
- *Responsive – through receptive attitudes and quick response we foster confidence and increase satisfaction levels.*
- *Restless – our sensitivity to diverse needs and proactive curiosity about new possibilities allows us to advance our knowledge and refine our thinking.*

At the May AIA Convention in Atlanta, the NCARB booth will feature larger engagement areas for visitors to talk with staff, updates on the progress of our initiatives, and periodic media outreach events—all wrapped in the “Let's Go Further” theme.

As we finalize our plans for our own Annual Business Meeting in June, we will use the revitalization of host city New Orleans as a motivation for our own revitalization efforts. I hope many of you reading this will be able to attend our meeting, and drop by our booth at the AIA Convention if you are in Atlanta.

“Going further” includes providing a more useful, rigorous path to licensure. It is about assisting our Member Boards by expediting information, improving support systems, and providing timely analysis. It extends to expanding the reach of licensed architects with reciprocal licensure. And it also means we are seeking additional ways to go further for NCARB Certificate holders by adding benefits.

An early peek at data sets being produced and analyzed for our 4th Edition of NCARB by the Numbers (to be issued at the Annual Business Meeting) reveals many positive indicators regarding those on the path to licensure, including decreases in duration, increases in diversity, and positive trends in engaging with our programs. Those facts, along with your continued encouragement, show that together we really can go further.

APPLYING OUR STRATEGIC PLAN**Facilitating Licensure**

- All systems are go for a July 1 launch of the streamlined IDP. As of that date, NCARB will be prepared to support jurisdictions who have adopted the changes to the IDP Guidelines regarding the elimination of elective hours and requiring reporting of core hours totaling 3,740. Forty-one jurisdictions have indicated that they plan to adopt the IDP streamline, with 35 ready to go on July 1. NCARB will continue to support Record holders seeking licensure in jurisdictions that have different experience requirements.
- Our Board of Directors formally approved the work of the Internship Committee in mapping a migration of core experience requirements from the current 17 areas into six categories. Known as the IDP Overhaul, this change will occur in July of 2016. Some supplemental experience will also transfer into the new format.
- We continue to make significant progress in developing ARE 5.0, and are increasingly optimistic about a fall 2016 launch date. The Examination Committee held their final meeting of the fiscal year at NCARB offices in early May. Registration for ARE divisions continues at an unprecedented rate, as a shortened retest waiting period and improving economy reinforce the “Getting it Done” campaign we launched last year.

Fostering Collaboration

- The topic of global licensure arises frequently when our teams conduct outreach visits around the U.S. Recently, we have had the opportunity to talk with representatives from other countries whose licensure frameworks have similarities to our own. A special team composed of chairs of our Education, Internship, and Examination Committees has been analyzing the similarities and differences between us and the requirements imposed in Australia and New Zealand. We are having a series of conversations with Brazil as they design a licensure path. And, we have sought interaction with those whose educational accreditation requirements mirror those of the NAAB.

The outcomes of these discussions are neither obvious nor easy. Few organizations other than NCARB, for example, have a program that acknowledges licensed foreign architects. Finding common ground is worthwhile, but it will only be achieved where there are recognizable metrics in place that could support future mutual recognition agreements.

Centralizing Credentialing Data

- The CEO Update to the Board at its April meeting included a remarkable statistic: 60 percent of jurisdictions are now either discussing data sharing or actively engaging in it, compared to just 7 percent one year ago. We are currently addressing individual issues around the legal interpretation of federal reporting requirements, and providing a path forward in many cases that seemed unresolvable.

- In early May, we were pleased to announce the selection of Roxanne Alston as the new Director of Customer Relations. Roxanne has served with distinction as an Assistant Director in that department. She has been a critical factor in successfully elevating the performance and approaches of this department, and we look forward to seeing her step into this senior staff position. Roxanne succeeds Doug Morgan, who moved over to head our Administration directorate.

- Submitted a balanced draft FY16 Budget for Executive Committee and Board of Directors review at their April 2015 meeting.

- Updated the Roster database to reflect changes to all Member Boards.

MARKETING & COMMUNICATIONS

- Released initial promotion to Certificate holders for NCARB's newest mini-monograph: **Indoor Environment: Part II**, Indoor Air Quality: Sources, Contaminants and Health Effects. NCARB will be announcing a new mini-monograph release every month. Certificate holders receive mini-monographs for free, and by passing the mini-monograph quiz can earn continuing education hours toward renewing their architectural license.
- Launched IDP Streamline communications campaign to inform our members and customers of the changes accompanying IDP streamline, when the changes will go into effect, and how the new requirements will affect aspiring architects based on their jurisdiction.
- The [April Architect Spotlight](#) featured 2014 Intern Think Tank (ITT) member Ralph Raymond, who discussed ARE strategies, keeping track of IDP hours, and the value in being part of a professional association.
- Continued working with the Examination directorate on the [ARE 4.0 Online Community](#) to increase community participation and support member needs. The community has now reached 2,883 members since it's launch in February.




CUSTOMER RELATIONS

- Continued to collaborate with Canadian provinces to resolve long-standing concerns over the transmittal process between Canada and the U.S.


Intern Applications:
July–April




Reciprocity Transmittals:

EXAMINATION

- Developed the first iteration of case study questions as part of the ARE 5.0 Item Development Subcommittee efforts. This new examination format will allow NCARB the ability to assess a candidate across multiple content areas that all relate to a similar project scenario.
- Prepared for the final meeting of the Examination Committee. Discussions during this meeting will cover strategic planning for both ongoing examination development, and the procedure to conduct the ARE 5.0 standard setting.
- Finalized the assembly and publication of next year's forms of the exam that will be available for candidates from July 2015 through June 2016. This yearly effort ensures continued examination security by constantly updating and refreshing the questions used to assess the candidates of the ARE.
- Completed enhancements to the My Examination portal to help Member Board's better control examination eligibilities.

- Created an IDP hours calculation help page as part of the IDP Streamline implementation.
