

# **GUIDELINES FOR SELECTING INDUCTEES INTO THE SOUTH CAROLINA LIONS HALL OF FAME**

## Nomination Guidelines for the South Carolina Lions Hall of Fame

- a. Each District may select four (4) Lions from its sub-district. The selections shall be made from written nominations received from the clubs of the sub-district.
- b. All nominations must be received by the district chairman no later than **January 31st**. Nominations received by the chairman after this date will not be considered.
- c. No individual Lion shall be nominated for the South Carolina Lion of the Year and for induction into the South Carolina Lions Hall of Fame during the same year.
- d. Guidelines for selection to the South Carolina Lions Hall of Fame:
  - (1) Any Lion or any deceased Lion, to be proposed for induction into the Hall of fame shall have a minimum of ten years membership in a Lions Club in South Carolina.
  - (2) It shall not be necessary for a candidate to have held a District, State or Club office.
  - (3) Any Lion in South Carolina may nominate a candidate for the Lions Hall of Fame, but the nomination must be endorsed by the candidate's home club.
  - (4) The proposal shall cover the candidate's accomplishments in Lionism and include his civic, professional and religious activities.
  - (5) Selection of inductees into the Lions Hall of Fame shall be based primarily on contributions to Lionism.
  - (6) Proposals for candidates not selected will be returned, by the committee chairman, to the clubs submitting them, immediately after the Annual Multiple District 32 State Convention.
  - (7) If a Lion is inducted into the Hall of Fame while living, they will not be eligible to be submitted as a deceased Lion. There is only one Hall of Fame.
  - (8) A plaque is to be presented to the ones so honored or to a family member. The presentation will take place at the Annual Multiple District 32 State Convention.
  - (9) A permanent book shall be placed in the State Lions Offices, in a place designated as the South Carolina Lions Hall of Fame. The book shall contain a picture of the member along with detailed information of his/her service.
