Following the success of our first two Residential Weekends we are returning to Renouveau for another chance to experience and sing different types of worship music, this time under the leadership of Miles Quick, Head of Congregational and Instrumental Music at RSCM. He is based in Taunton, where he is Director of Music at St Mary Magdalene Church and studied music at Durham University and the Royal Academy of Music. He was Director of Music at Queen's College, Taunton (a Methodist foundation) for seven years before deciding to concentrate on church work full-time. He has also served as Musician in Residence at Holy Trinity Anglican Church in Vancouver.

There will be practical sessions, services, and an informal concert, including music by Handel (Zadok the Priest), Paul Isom and Vaughan Williams, plus traditional and modern hymns suitable for different situations and for the theme of Her Majesty The Queen's 90<sup>th</sup> birthday. There will also be opportunities for participants and accompanying family/friends to enjoy the facilities of this lovely holiday venue. The Residential Singing Weekend is open to RSCM Affiliates, Members and Friends and non-members alike. Dress casual – no robes.

Sunday	Breakfast, morning session, Holy Communion at St John's church in St Raphaël, lunch, end of weekend.

Transport from the airport or the station can be arranged at extra cost. There is a bus service from the airport to Fréjus leaving at 15.45 on Friday and the return bus leaves at 14.10 on Sunday, arriving at the airport at 15.25. This is the cheapest option so please arrange your flights accordingly. Otherwise, we can arrange for a taxi from the airport but this is very expensive as it is 1 hour's journey. We will organise taxis from the bus station and railway station as required.

## TERMS AND CONDITIONS

All fees are payable in euros. All bank charges must be paid by the applicant.

Fees are subject to change only in the event of circumstances beyond the control of RSCM France, including changes in taxation and exceptional surcharges imposed by suppliers.

### Day courses

**Full payment, which covers administration costs, is required at the time of booking and is non-refundable** (except in the event of the course being cancelled by RSCM France).

### Residential courses

**A deposit of 30% of the full fee is required on booking** for residential courses.

**Deposits cover administration costs and are therefore non refundable** (except in the event of the course being cancelled by RSCM France).

**The balance of the full fee is due 4 weeks before the course.** After this date, RSCM France reserves the right to re-allocate any places for which the fee has not been paid in full.

**In the event of cancellation by the applicant** more than 4 weeks (30 days) before the start of the course, amounts paid in advance, except for the deposit, will be refunded.

### All courses

In the case of cancellation by RSCM France, all fees paid will be refunded in full.

RSCM France cannot take responsibility for any other costs incurred due to cancellation, whether this is by the applicant or by RSCM France, or for reasons beyond our control (such as adverse weather or strike action).

**For this reason, we strongly recommend that you take out your own travel insurance.**

RSCM France reserves the right at any stage to refuse an application without stating the reason.

If a tutor or lecturer is absent, RSCM France will provide a suitable replacement.

RSCM France reserves the right to alter other features of the course, including venue, programme and facilities.

Please notify RSCM France of any special access, mobility, medical or dietary requirements when you first book to attend, especially if these will affect your ability to participate fully. RSCM France will endeavour to help where possible.

Any dependent adult student must be assisted by a full-time carer paying their own costs. RSCM France is unable to accept responsibility for the supervision of dependent adults in the care of students attending courses.
