Our last general meeting featured Chris Reykdal, candidate for Superintendent of Public Instruction. Members of Mason County School Boards were invited, but only two showed,

Shelton School Board Chair Brenda Hirschi and School Board Member Cheryl Williams, who is running for re-election. Chris made a good case for why he should be elected as our next Superintendent. I have not heard of any other campaigns, so we will keep an eye on this one for future support action by the Party. Chris also gave a presentation along with Senator Ann Rivers at a recent Washington State School Directors Association meeting in Seattle. This bi-partisan panel's main message was, "You can't drink, gamble or smoke your way to education funding." Besides the "sin" taxes, their group looked at capital gains taxes and advocated for local levies funding local school projects. They have introduced Bill 6130 and have scheduled listening sessions throughout the state in the next few months. Education is a big deal in Washington State because the framers of our Constitution included in Article IX, Section1, mandating "it is the paramount duty of the State to make ample provision for the education of all children residing within its borders."

There are a few opportunities to listen to local candidates who are running for various offices. Please try to attend and show support for these citizens who are willing to inconvenience their private lives to serve the public. Coming up on October 6 at 6 p.m. will be a candidate forum sponsored by the Hood Canal Improvement Club in Union to be held at the Alderbrook Yacht and Golf Club. On October 13 at 2 p.m. the Mason County Senior Activities Association will sponsor a candidate forum at The Pavilion. The Association is partnering with the League



of Women Voters, who will moderate the event.

Our next general meeting will be Wednesday, October 14, at the Grove Street Brewhouse at 6:00 p.m. for social time. The meeting will begin promptly at 6:30 p.m. We expect to discuss the election process coming up for 2016.



Washington State Democrats State Meeting in Wenatchee, September 19-21 Resolutions Passed

739 The transportation package and operating budget must be placed on the ballot as required by (Tim Eyman's) Initiative 960.

Resolved, that we **support Advisory** votes 10-13 on the November ballot.

Resolved, that we support Initiative 1401 on the November ballot.

PCO Update/Concerns

An information handout about the electoral process, including important voting dates, has been created, for the purpose of contacting potential voters. This handout ("flyer" or "information flyer") will be used to help get folks registered. The flyer was also mailed to each PCO, along with suggestions for ways to use it. The data collected can help us update the VoteBuilder database for each individual in each precinct.

As a beta-test, I used the flyer to doorbell. My results? Out for 1.5 hours. Knocked on 30 doors. 11 real people contacts (37%), 9 doors with little information other than an occasional name (30%), 2 no trespass signs (do not go there), 2 with locked gates (in a regular effort leave brochure). From this effort it was calculated 27% of these doors are worth door belling, 13% can be ignored and 27% are the ones to be called after the ballots come out to make sure they send theirs in to be counted!

This is very important: During the initial walk-about, everyone took the handout!! It had information they could

use. Who knows what they did with it, but even an individual who wants Obama gone put the handout in their pocket. They were much more willing to talk and ask questions than during regular election handout sessions.

A few quick notes from the field test:

- 1. First, be sure to get the name on the mail box. This is to help cross match the number address with the voter data base.
- 2. Second, it has been suggested that a 4th sub-division needs to be added, at least in the outlying areas. Check to see if the house might be a vacation home. If this is not the voting address, ignore it along with the other party(s)' people.
- 3. Third, remember we are not trying to get votes at this stage; we are trying to get potential voters, first by registering them (hopefully as Democrats), second by building a real-time database that will help us contact them to get their vote when it counts.

One does not have to be a PCO to

conduct this walk-about and collect these data. Contact your PCO, however, to get the voter lists so that you can update them with your results.

If you cannot conduct a walk-about or make it to the meetings (every second Wed. of the month), or hate that type of activity, perhaps you can contribute with some of these non-meeting events, like yard sales, or phone-calling. We may be setting up some information booths in high traffic areas--can you sit and hand out stuff for a couple of hours?

Again, this note is being published here in the hope of generating feedback on what members reading this newsletter might like included. I still stand by this statement, but now I am concerned about how many individuals are actually reading this newsletter as well. So far that has still been a big bust, but I am a concerned Democrat and will continue to try to drum up support to get real Democrats elected!

What is important is for everyone to please find some way to help!



I have a challenge for you all (or at least those of you who support the notion of a state income tax). While we are not required to pay a state income tax, there is nothing in state law prohibiting us from doing so.

So ...

- 1. Pick a state, any state that has an income tax. Maybe a state you've lived in, want to retire to, have children living in, hope never to ever, ever visit ... pick a state.
- 2. Go to this website http://www. bankrate.com/taxes.aspx some other that will provide tax rates state by state) and find what state income tax rate you'd pay if you lived there. In my experience, it's generally based on a percentage of taxable federal income.
- 3. Using your most recent tax forms, calculate your hypothetical state income tax.
- 4. Then go to this Website: http://

www.irs.gov/Individuals/ Sales-Tax-Deduction-Calculator. This will take you through a series of pages to determine the estimated sales tax you would pay wherever you live based on income, number of deductions, and zip code. NOTE, this is calculated on your GROSS income - you can deduct either income tax paid OR sales tax but not both from federal taxes if you itemize, so it's a pre-deductions

5. Add the two together: the hypothetical income tax you'd pay and the estimated sales tax you'd pay, both for your chosen alternative state.

calculator.

- Now, go back to the IRS site: http://www.irs.gov/Individuals/ Sales-Tax-Deduction-Calculator and figure the estimated sales tax for your actual, real, Washington State ZIP code.
- 7. Subtract the (estimated) sales tax you pay in Washington (#6) from the total tax you'd pay in

- some other state (#5), and yes, I'm assuming you'd be paying more.
- 8. You now have a dollar figure for what TAXES you would have paid in your chosen state - income tax plus sales tax, over and above what sales tax you paid in Washington.
- 9. Now's the hard part ... if you believe we should have an income tax, pledge to contribute this amount to your city or county over the next year. You can specify what it's used for (which of course you can't if it's a required tax, but since it's voluntary, support something you \(\bigviever\), to use a common vernacular.

It is a challenge I made to myself this past year, and have met; I intend to do it again in 2016 – I wouldn't suggest any of you do more than I am willing to do myself, but having never, ever lived anywhere before that didn't have a state income tax, it may be easier for me than for someone who's never paid it. Cheers!
