

**Ski/Snowboarding Trip Date: February 27, 2016**  
**Permission, Acceptance of Risk, Waiver and Release Agreement**

In consideration of Rolling Hills Prep School's voluntary ski trip to Snow Summit, Bear Mountain or Sierra Summit Resorts, please read the following statements and affix your understanding and agreement by signing below.

**PERMISSION**

I hereby certify that I have legal custody of the below-named student with due authority to sign this agreement I hereby give my child full and unequivocal permission to participate in the Rolling Hills Prep School ("School") winter expedition to Snow Summit, Bear Mountain or Sierra Summit (Resorts). I recognize and accept on my behalf of my child the risks and hazards detailed below and give my child permission having so acknowledged and accepted these risks.

**ACKNOWLEDGEMENT OF RISKS**

I am aware that participation in winter activities, particularly The Sport of Snow sliding in its various forms (including taking lessons and the use of all types of snow-sliding equipment; the use of all Terrain Features or Half Pipes; any intentional or unintentional jumping at any location; and the use of chairlifts or surface tows) INVOLVE RISKS OF PROPERTY DAMAGE, INJURY OR DEATH that no amount of care, caution, instruction or expertise can eliminate. Such dangers include, but are not limited to, variations in terrain and surface conditions, falls, loss of control, collisions with other snow sliders or with natural and man-made objects, and potential falls from or other accidents involving terrain features or chairlifts or other forms of transportation or vehicles that may be necessary for the conduct of Resort activities. PARTICIPANT FREELY ASSUMES ANY AND ALL RISKS, whether or not the actual risk is known or unknown to Participant at the time of executing this release and waiver agreement AND INCLUDING THE RISK OF ANY NEGLIGENCE ON THE PART OF ROLLING HILLS PREP SCHOOL'S affiliates, respective officers, board of trustees, employees, volunteers, agents or representatives.

I recognize that the Resorts areas are large and that the School cannot and will not patrol each slope on which students ski. Skiers ski unsupervised, and under their own direction. I agree that it is my child's duty to follow all Trip rules and procedures and to maintain their own physical safety. I also acknowledge that, even if he/she does his/her utmost, he/she will still be exposed to significant physical risk. *Students are responsible for the soundness of their own decisions re choice of slopes to ski, speed to ski, and election to attempt jumps.*

I also understand and accept that independence, responsibility, and autonomy are important elements of the learning experience. Consequently, students will be treated as young adults, provided with limited direct supervision, and held responsible for their own actions. The School accords its students a high level of trust; it will be my child's duty to follow the stated rules in the explicit absence of moment-to-moment faculty enforcement. *I specifically understand and accept that my child will be allowed to ski unsupervised anywhere on the mountain he/she chooses and to travel unsupervised among the ski area, our condos, and town, subject to the limitations stated in the rules.*

**RELEASE**

I voluntarily release, discharge, waive, and relinquish all claims or actions that I may have against Rolling Hills Prep School, its officers, board of trustees, agents, employees, and volunteers for bodily injury, emotional distress, property damage and/or wrongful death occurring to the below named student, arising out of or in any way connected with this expedition, including, but not limited to those claims arising out of any negligence on the part of Rolling Hills Prep School, its affiliates, respective officers, board of trustees, employees, volunteers agents or representatives, except only those claims due to fraud or willful injury to student, or in violation of law by Rolling Hills Prep School, its affiliates, respective officers, board of trustees, employees, volunteers agents or representatives, whether willful or negligent.

*I UNDERSTAND THAT THE ABOVE ACTIVITIES ARE VOLUNTARY AND NOT REQUIRED BY THE SCHOOL. I UNDERSTAND IF I AM NOT COMFORTABLE WITH THE STATEMENTS MADE ABOVE, I SHOULD NOT SEND MY CHILD ON THIS TRIP. MY SIGNATURE BELOW INDICATES THAT I HAVE ACCEPTED THE TERMS OUTLINED. I HAVE REVIEWED THIS DOCUMENT WITH MY CHILD WHOSE SIGNATURE INDICATES ACCEPTANCE OF THE RISKS AND RESPONSIBILITIES OF THIS TRIP AND CONSTITUTES A PLEDGE TO OBEY ALL TRIP RULES.*
