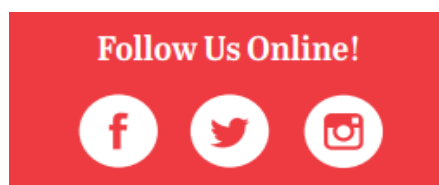

Meal Packing:

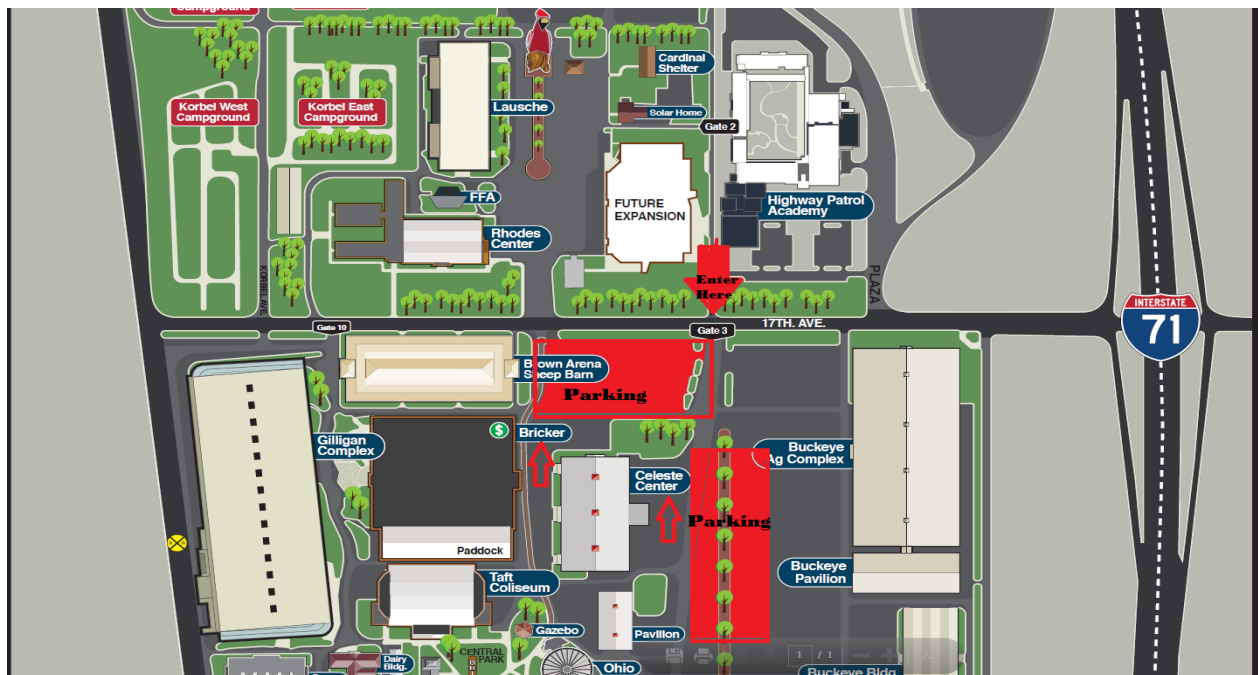

Keynote Speakers



Josh Shipp

Josh Shipp is the host of TV Show JUMP SHIPP, author of "The Teen's Guide to World Domination" (St. Martins Press), named a CNN Young Person Who Rocks and was listed on INC. Magazine's 30 under 30 list.

Josh has established an international reputation as a teen communication expert. He's spoken at Harvard University, Stanford, UCLA, M.I.T. and to over two million teenagers live. He is a recognized teen expert for such media outlets as MTV, CNN, and FOX. Josh offers up a healthy dose of advice that he calls "in your face, but on your side." He counsels teenagers on everything they care about and it's all done in a youth-friendly, humorous tone that is more hilarious survival guide than preachy sermon.

Josh certainly knows a thing or two about survival. Abandoned and abused as a child, he was able to triumph over the tragedy. He attributes his personal growth to the support of a great foster family, dynamic teachers and enriching school programs that opened his eyes to his true potential. After serving as State DECA President and on the School-to-Work student advisory committee, Josh decided to commit his life to helping teens.



Jackie Ulm

Born and raised in Mentor, Ohio, Jackie Ulm began competing in track and field in junior high school and continued to compete at Mentor High School. In 1997 and 1998, she placed 5th and 4th, respectively, at the Ohio Track & Field State Meet in the discus throw. She started her hammer throw career upon enrolling at Ashland University in Ashland, Ohio, as a member of the track and field team for the Ashland Eagles under throwing coach Jud Logan in the fall of 1998. While competing for the Eagles, she was a five time NCAA Division 2 National Champion and a 9 time Great Lakes Intercollegiate Athletic Conference (GLIAC) champion. She still holds the Ashland University school record and the NCAA Division 2 National Meet record in the hammer throw. In 2003, Jackie was featured in Sports Illustrated's Faces in the Crowd.

After graduating from Ashland University in May 2003 with a mathematics degree, Jackie joined Ashland Elite's athletic program, which was devised to help Olympic aspirants undergo rigorous training for future track and field meets.

Jackie represented the United States at the 2004 Summer Olympics in Athens, Greece, in her official international debut.

Jackie currently lives in Hilliard with her husband Richard and their two standard poodles. She is currently an analyst at JP Morgan Chase. Jackie continues to make health, wellness, and fitness an essential part of her life.

Student Conference Attendees

Delegates are expected to attend and participate in sessions, workshops, expo, and other activities. All conference attendees should be informed of the following:

- Behavior at all times should be such that it reflects a positive, professional image of you, your school, and the organization.
- Be on time for all sessions and remain until sessions are adjourned.
- Conference badges are required to be worn at all times.

Adviser and Chaperone Responsibilities

Advisers and chaperones are responsible for the behavior and discipline of their students throughout the conference. Attendees causing a disturbance or displaying inappropriate behavior will be asked to leave the meeting.

- Advisers/chaperones are responsible for enforcing the Mandatory Dress Policy. The Mandatory Dress Policy applies to delegates, advisers, guests, and all other attendees at the State Leadership Conference. Thoroughly review and impress upon your delegation the importance of adhering to the Mandatory Dress Policy.

Meals

- No meals are included with conference registration. All attendees are responsible for their own meals.
- Concessions will be available for purchase.

Mandatory Conference Dress Code Policy

The dress code is required at all sessions, exhibits, workshops, and election activities. Advisers are responsible for enforcing the dress code policy with their students and guests. **The Ohio State Executive Council challenges members to have a sea of red at SLC this year!**

Females

- Red, black, or white polo or oxford shirt with a collar (long or short sleeves)*
- Black dress slacks or capris (no shorts)
- Black skirts no shorter than 2 inches above the knee
- Black sheath dress no shorter than 2 inches above the knee
- Black dress shoes
- Jeans, t-shirts, and athletic wear are NOT acceptable

Males

- Red, black, or white polo or oxford shirt with a collar (long or short sleeves)*
- Black dress slacks (no shorts)
- Black dress shoes
- Business professional
- Jeans, t-shirts, shorts, and athletic wear are NOT acceptable

Advisers / Chaperones / Guests

- Business professional
- Jeans, t-shirts, shorts, and athletic wear are NOT acceptable

*Polo shirts and oxford shirts are not required to have the FCCLA logo, but FCCLA branded shirts are strongly encouraged. All current and future attire with the FCCLA logo must be purchased through the official FCCLA emblematic supplier. Unacceptable Attire at FCCLA Events

- Skin-tight or revealing clothing
- Midriff-baring clothing
- Extremely short skirts or dresses (shorter than 2 inches above the knee)
- Clothing with printing that is suggestive, obscene, or promotes illegal substances
- Athletic clothing, including tennis shoes
- Rubber, beach-type flip flops
- Night wear (pajamas) should NOT be worn outside of your hotel room

The Ohio Career Development Events Handbook is located on www.Ohiofccla.org. Advisers and participants are responsible for following all rules and regulations outlined in this document.

CDE Name Changes/Substitutions

Advisers can complete name changes/substitutions in the registration system. Changes made after the close of the registration system are to be made on the day of the event by completing the Participant Change Form post on www.ohiofccla.org .

CDE Event Cancellation

Event cancellations can be completed in the registration system by deleting the event. Event cancellation after the close of registration is to be completed using the [CDE cancellation link](#).

State Degree and Outstanding Chapter:

State Degree and Outstanding Chapter participants will be evaluated on April 28th. See the competition schedule for your chapter's scheduled time.

Career Development Event Schedule:

The competitive event schedule will be posted on April 21, 2016.

Event Check-in:

All competitors are to check in at the CDE registration booth 15 minutes prior to their scheduled competition time. All portfolios and binders will be dropped off at the registration booth when checking in. Competitors are responsible for retrieving all competition materials by 3:30 PM.

Event Displays:

This year displays will be set up at the time of competition in the evaluation space. Displays for Chapter in Review Display, Chapter Service Project Display, Fashion Design, Fashion Construction, Recycle and Redesign, and National Programs in Action will be placed in the CDE display showcase at the conclusion of their competition. All displays should remain in the showcase until 3:00 PM and must be removed by 3:30 PM.

Onstage Career Development Event Recognition and Seating Assignments:

Competitors who receive a gold rating or are ranked in the top 3 in their respective Career Development Event will receive on stage recognition. A Google Doc will be posted to the Ohio FCCLA website with a list of gold rated/top 3 competitors only at the conclusion of Thursday's competitions. The top two places will be considered a National Qualifier.

Students who receive a gold rating/top 3 are to report to their assigned seat during the pre-session prior to the recognition session for that CDE. Seating assignments for each session will be posted on the Ohio

FCCLA website. Gold rated/top 3 competitors not in their assigned seat will be unable to receive proper recognition.

Career Development Rubrics Pick-up:

Career Development Event Rubrics will be available for pick up at the registration upon the conclusion of closing session. Rubrics not picked up will not be mailed.

National Qualifier Form:

Each adviser will complete the National Qualifier Form posted on www.ohiofccla.org . Insert all competitions for each chapter and indicate whether they would like to represent Ohio at National Leadership Conference. This form must be turned into the registration desk upon arrival at State Leadership Conference. If the form is not received, the chapter will be disqualified from advancing to Nationals.

The top two entries are considered the National Qualifiers. If a top school is unable to attend Nationals, alternates will be determined in descending order of rank for each category and event. A list of all National Qualifiers will be posted on the Ohio FCCLA website on Monday, May 9th.

Voting Delegate Information

Voting Delegate Information

Each chapter should select voting delegates to participate in the Regional and State Executive Council elections on Thursday, April 28th. Voting delegates must be FCCLA members. Chapter delegate numbers are based on paid affiliation by March 1st. See State Conference tab on the Ohio FCCLA website to determine your chapter's number of delegates.

Responsibility of ALL Voting Delegates at State Leadership Conference:

- Voting Delegates have an important role. Delegates are responsible for voting on behalf of their chapter members at the Business Session and during the Regional Executive Council election session.
- Voting Delegates will need to sign in at the beginning of both the business session and Regional Executive Council Session.
- Voting Delegates must be wearing a black lanyard in order to enter.
- Voting Delegates must be in attendance at the Regional Executive Council election and business session in order to cast their votes. See Conference Schedule for times and locations of events.
