been taught to recognize, as the very embodiment of the the rabbinate. mitzvah of pidyon shevuyim, redeeming captives. The wound suffered by the American Zionist Jewish community during my lifetime.

In certain circles, the ongoing imprisonment of Mr. Pollard, for years, and even decades, longer than some convicted of espionage on behalf of enemies of the United States, was clear evidence of anti-Semitism. Moreover, the stories which emerged out of the federal prison in North Carolina in which Mr. Pollard was languishing (including one anecdote in particular which I remember hearing as a child of his tefillin being confiscated which I found profoundly disturbing), which conveyed unusually harsh treatment, were certainly distressing, to say the least. Images of his long suffering wife Esther pleading for her husband's release tugged at the heartstrings, I can only imagine, of every warm blooded Jew. Even if one assumed that, as many with access to classified government information have repeatedly claimed, the sheer amount of information which the Jewish state received from Mr. Pollard was far in excess of any other intelligence leak in American history, that the information leaked required the United States to completely revise its method of transmitting signals based intelligence¹, and that much of the Pollard information eventually made its way to Moscow, gravely endangering other clandestine agents overseas, it was certainly a commonly held sentiment that 'enough was enough'. His seemingly interminable incarceration for protecting Jewish people in Israel made him, within these circles, a Jewish hero, a modern day martyr.

Yet, in retrospect, there was that which they did not tell us in day school. While we had been educated that Mr. Pollard did what he did for the safety of every man, woman, and child in the State of Israel, we were not told he was paid handsomely for his work. While we were told that Israel had 'the right' to all of the information which was shared, we were not told that he had contacted other countries (purportedly South Africa) concerning accessing his information. Finally, we certainly were not made aware of the degree to which aspersions of divided loyalties have dogged Diaspora Jewry for centuries, if not millennia. In committing his crime, Mr. Pollard was substantively compromising the standing of the Jewish people in the United States, not to mention harming the US-Israel relationship, which itself served to protect Jewish people in Israel.

As such, as this terrible saga appears to be coming to an end this November, very reasonable, wellintentioned American Jewish citizens with strongly held Zionist sentiments, can certainly disagree about the last thirty years. I do not possess, nor do I believe any rabbi possesses, special insight into this deeply painful chapter

> Tragically, the annals of Jewish history are literally overflowing with blameless Jews, guilty of no crime whatsoever, let alone treason, being cynically kidnapped, never to see their loved ones again. Jonathan Pollard, it must be stated clearly, was not one of them. The saintly memory of those martyrs, throughout the ages, and their tortured families, demands of us at least this modicum of discrimination.

Maimonides has already privileged the commandment of tzedakah above all other positive commandments. In privileging redeeming captives even above conventional tzedakah, and in doing so twice, Maimonides is exalting redeeming captives into truly rarified territory.

House Dem: Iran deal 'simply too dangerous'

A House Democrat on the Foreign Affairs Committee came out against the Iran nuclear deal Wednesday, as the White House seeks to gather Democratic support. According to The Hill, Rep. Grace Meng (N.Y.) said the "deal before us now is simply too dangerous for the American people." "I strongly believe the world could and should have a better deal than that set forth in the Joint Comprehensive Plan of Action, which I will therefore oppose," said Meng, who is a member of the Foreign Affairs subcommittee on the Middle East. Meng added that she would continue to study the finer points of the deal, but said, "they will not be dispositive for me." Her remarks come a day after she questioned Secretary of State John Kerry and other top administration officials during a panel hearing on Tuesday, Meng called the inspections procedures "flawed," and said leading nuclear experts have asserted that inspectors would "not necessarily know" if Iran was manufacturing uranium components for a nuclear weapon. "This is unacceptable," she said.
