## Child Care Licensing Update June 2015

The drafts for the Registered & Licensed Family Child Care Homes and Center Based Child Care and Preschool Programs Child Care Regulations are in their final stages of completion at the Child Development Division, and are now on a specific timeline:

- 1. Proposed Rules will be available to the public on the Department for Children and Families, Child Development Division website as of August 8, 2015.
- 2. Public Comment Period August 8, 2015 September 23, 2015 (Comments can be submitted through Survey Monkey, by mailing comments to the division, and by attending one of the hearings)
- 3. Vermont Interactive Technologies (VIT) Hearings for Public Comment: Bennington, Brattleboro, Johnson, Lyndonville, Middlebury, Newport, Randolph Center, Rutland, Springfield, St Albans, White River Junction, Williston, Montpelier will take place on:
  - Monday, September 14, 2015, 9:00 11:00 AM
  - Wednesday, September 16, 2015, 6:15 8:15 PM
- 7. CDD Review of Public Comments & Regulation Revisions, and making any changes based on the comments October 2015
- 8. File Final Proposed Rules with Legislative Committee on Administrative Rules (LCAR) Mid-November 2015
- 9. LCAR (Legislative Committee on Administrative Rules) Hearing Date TBA ,likely in Jan. 2016.
- 10. Adoption of Regulations
- 11. Provider Training on New Regulations CDD is proposing that these two sets of regulations will be effective on September 1, 2016.

There is a good possibility that **all** providers who have not taken a child development course will need to take the Fundamentals for Early Care and Education course; you might want to consider getting a jump on the new regulations by taking the course now. See page 3 for more details.

#### Who should take Fundamentals for Early Childhood Professionals?

The Fundamentals course meets the education requirement in the Vermont child care licensing regulations for Teaching Assistants and lays a good foundation to obtain the CDA credential. The Fundamentals course is specifically suited for early childhood professionals who:

- Are beginning to work in the field of early childhood (birth-age 8)
- Have taken child development courses in high school or a regional technical center
- Have worked in the early childhood field for a long time but have not taken a college course in child development or applied for any Northern Lights career level certificate.

Fundamentals will provide you with a foundation in child development and developmentally appropriate practices, including child guidance, communicating with families, cultural sensitivity, and health and safety - all vital components to quality care. Knowing what children are typically capable of at various stages of development will help you provide environments and experiences which are age appropriate, decreasing frustration levels for children. Developing your curriculum based on observations of children's strengths and interests will support children's social emotional well-being and promote more engagement, reducing challenging behaviors as well.

All providers who successfully complete the course and have worked in the field for one year can apply for a Northern Lights Level I certificate and receive a \$100 bonus.

**T. Sept. 8:** <u>Introduction to the Fundamentals:</u> Addresses course expectations and requirements, ethics, confidentiality; giving & receiving constructive feedback as well as portfolios/professional development documentation and CDA connections. **CDA # 5, 6** 

- **Sept. T. 15:** <u>Healthy and Safe Environments:</u> Members from VT's Licensing Team will answer your questions regarding licensing regulations, discuss ways to provide safe and healthy environments for children, and how the regulations are linked to Developmentally Appropriate Practice (DAP). **CDA # 1, 5, 8**

What is ARC?\_ARC is a framework for intervention with youth and families who have experienced multiple and/or prolonged traumatic stress. ARC identifies three core domains that are frequently impacted among traumatized youth, and which are relevant to future resiliency. ARC provides a theoretical framework, core principles of intervention, and a guiding structure for providers working with these children and their caregivers, while recognizing that a one-size-model does not fit all.
