FELONY COMPLAINT

The undersigned is informed and believes that:

COUNT 1

On or about June 13, 2016, in the County of Los Angeles, the crime of MURDER, in violation of PENAL CODE SECTION 187(a), a Felony, was committed by JOHNNY JOSUE SANCHEZ, who did unlawfully, and with malice aforethought murder JOHN DOE #135, a human being.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code Section 1192.7(c) and a violent felony within the meaning of Penal Code Section 667.5(c)."

COUNT 2

On or about June 13, 2016, in the County of Los Angeles, the crime of MURDER, in violation of PENAL CODE SECTION 187(a), a Felony, was committed by JOHNNY JOSUE SANCHEZ, who did unlawfully, and with malice aforethought murder JERRY DEAN CLEMONS, a human being.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code Section 1192.7(c) and a violent felony within the meaning of Penal Code Section 667.5(c)."

COUNT 3

On or about June 13, 2016, in the County of Los Angeles, the crime of MURDER, in violation of PENAL CODE SECTION 187(a), a Felony, was committed by JOHNNY JOSUE SANCHEZ, who did unlawfully, and with malice aforethought murder MARY ANN DAVIS, a human being.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code Section 1192.7(c) and a violent felony within the meaning of Penal Code Section 667.5(c)."

COUNT 4

On or about June 13, 2016, in the County of Los Angeles, the crime of MURDER, in violation of PENAL CODE SECTION 187(a), a Felony, was committed by JOHNNY JOSUE SANCHEZ, who did unlawfully, and with malice aforethought murder JOHN DOE #137, a human being.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code Section 1192.7(c) and a violent felony within the meaning of Penal Code Section 667.5(c)."

COUNT 5

On or about June 13, 2016, in the County of Los Angeles, the crime of MURDER, in violation of PENAL CODE SECTION 187(a), a Felony, was committed by JOHNNY JOSUE SANCHEZ, who did unlawfully, and with malice aforethought murder JANE DOE #44, a human being.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code Section 1192.7(c) and a violent felony within the meaning of Penal Code Section 667.5(c)."

It is further alleged as to count(s) 1, 2, 3, 4 and 5 that the offenses charged in counts 1, 2, 3, 4, and 5 are a special circumstance within the meaning of Penal Code Section 190.2(a)(3).

It is further alleged as to count(s) 1, 2, 3, 4 and 5 that the murders of JOHN DOE #135, JERRY DEAN CLEMONS, MARY ANN DAVIS, JOHN DOE #137 and JANE DOE #44, was committed by defendant(s), JOHNNY JOSUE SANCHEZ while the said defendant was engaged in the commission of the crime of ARSON, within the meaning of Penal Code Section 190.2(a)(17).

COUNT 6

On or about June 13, 2016, in the County of Los Angeles, the crime of ATTEMPTED WILLFUL, DELIBERATE, AND PREMEDITATED MURDER, in violation of PENAL CODE SECTION 664/187(a), a Felony, was committed by JOHNNY JOSUE SANCHEZ, who did unlawfully and with malice aforethought attempt to murder ANTHONY ROBERTS, a human being.

It is further alleged that the aforesaid attempted murder was committed willfully, deliberately and with premeditation within the meaning of Penal Code section 664(a) and is a serious felony pursuant to Penal Code section 1192.7(c).

COUNT 7

On or about June 13, 2016, in the County of Los Angeles, the crime of ATTEMPTED WILLFUL, DELIBERATE, AND PREMEDITATED MURDER, in violation of PENAL CODE SECTION 664/187(a), a Felony, was committed by JOHNNY JOSUE SANCHEZ, who did unlawfully and with malice aforethought attempt to murder ROBERT FERNANDEZ, a human being.

It is further alleged that the aforesaid attempted murder was committed willfully, deliberately and with premeditation within the meaning of Penal Code section 664(a) and is a serious felony pursuant to Penal Code section 1192.7(c).

NOTICE: Conviction of this offense will require the defendant to provide DNA samples and print impressions pursuant to Penal Code sections 296 and 296.1. Willful refusal to provide the samples and impressions is a crime.


NOTICE: The People of the State of California intend to present evidence and seek jury findings regarding all applicable circumstances in aggravation, pursuant to Penal Code section 1170(b) and *Cunningham v. California* (2007) 549 U.S. 270.

NOTICE: A Suspected Child Abuse Report (SCAR) may have been generated within the meaning of Penal Code §§ 11166 and 11168 involving the charges alleged in this complaint. Dissemination of a SCAR is limited by Penal Code §§ 11167 and 11167.5 and a court order is required for full disclosure of the contents of a SCAR


