TIMELINE FOR 2016 APPOINTMENTS

MAY 2015

The deadline date for submitting 2016 C.A.R. Committee Leadership and Specialized/Advisory recommendations (Chair, Vice Chair or Issue Chair of Standing Committees, and Chair, Vice Chair or Members of Special or Advisory Committees) for 2016 is May 15, 2015.

JUNE 2015

Leadership Team reviews all committee recommendations for Leadership and Members on Specialized/Advisory positions.

JULY 2015

Members can submit recommendations ONLY for membership positions on Standing Committees.

2016 Regional Chairs to notify C.A.R. via the online Committee Selection Process of 2016 C.A.R. Committee Regional Representatives/Liaisons.

The deadline date for both of the above items is July 24, 2015
