Hi Dana, can you update us on the repair of the water pipe that was reported about a few weeks ago in the Napa Register?

City Manager Dana Shigley from City of American Canyon

Michael: The Contractor has been given a Notice to Proceed and you may have seen some surveying and other preliminary work along the highway. The Public Works director met with them today and we expect to see construction begin within the next few weeks - we don't have a specific date yet. Our own crews are completing some of the preliminary work. In the mean time, staff is up there checking for leaks and monitoring the line. Total construction time will be several months, and we can't shut down the line down until water demand in the City has declined (ie, irrigation has mostly stopped) so other main lines can handle the demand.

Subject: Gas taxes

It has always been my understanding that gas taxes were designed to be used for roads. What is the status of the use of our gas taxes?

City Manager Dana Shigley from City of American Canyon

Jim P: I'm going to respond to both together.

What is the status of the use of our gas taxes?

Gasoline taxes are paid by consumers when they purchase gasoline. The State collects these revenues and distributes them to individual cities and counties primarily based on population. So, with gas taxes, it doesn't matter where you purchase your gas; American Canyon gets its share based mostly on where you live. (You also pay sales tax on gasoline, but that is a separate topic). Gas taxes must be used to maintain and improve local streets and roads per state law. In 2015/2016, the City of American Canyon anticipates receiving around \$450,000 in gasoline tax revenues; however, we spend \$665,000 on basic maintenance of our streets and roads. The additional \$215,000 comes from general fund revenues (sales tax, property tax, etc.).

The City spends its street maintenance funds to replace signs; maintain striping; fill pot holes; slurry seal streets; cut back trees when they are a hazard; take down yard sale signs that are affixed to street signs; purchase concrete, asphalt, paint, fencing and other supplies; install curb ramps; maintain the signals and street lights (unless paid by one of the lighting districts); and purchase tools. The City also uses gasoline taxes for projects such as the repaving of Donaldson Way, Lena Drive and Stetson Drive and sometimes to match grants for larger projects (including the Park and Ride by the library and Theresa Avenue paving). It costs roughly \$600,000 to grind and repave a local city street; \$450,000 is not enough money each year to fully maintain our streets, let along make much headway on reconstructing streets.

Broadly speaking, gasoline tax revenues are a dwindling revenue stream and are not even close to keeping up with need statewide. The primary reason why gasoline taxes aren't keeping up is fuel efficiency. Cars are getting more and more efficient (a good thing), but that means consumers buys less gas (from this perspective, a bad thing). Consumers are driving the same amount or more as they always have, causing wear and tear on streets, yet consumers pay less gas tax. Various states (including California) have talked about charging gasoline taxes based on miles driven rather than gallons purchased as a way of more equitably allocating the costs of street maintenance to the user. However, that has not happened.

As many communities have done, voters in Napa County approved a local sales tax measure to provide a reliable funding stream for street maintenance. Measure T will impose a one-half cent sales tax on transactions in Napa County and goes into effect the same time the current Measure A (for flood control) expires in 2018. The City of American Canyon anticipates receiving around \$800,000 per year from Measure T starting in 2018. This will go a long way to repairing the backlog of old, rough streets. One of the items in the City Council's strategic plan is the creation of a plan for the specific use of these funds so we can be ready to go when the revenues become available. Until then, we will continue to do projects and make the best use of the modest revenues we have.

Is there a plan for taking care of the infrastructure in the older parts of the city?

I will address water and sewer here, as I have already addressed streets under your question about gas taxes.

Underground infrastructure in some of the older parts of town was built according to construction standards that are not as stringent as they are today and infrastructure is deteriorating in some places. When the City incorporated, it inherited substandard infrastructure.

We have tackled some important projects in the last few years, including complete replacement of the water main along the highway (which is currently underway), the repair of nearly 100 water service leaks (with 60+ more on the way), replacement of all water meters, several projects to bring the wastewater treatment plant up to date (new membranes, screening, and others), replacing membranes at the water treatment plant, and replacement of key water valves in the City. Most of these improvements are invisible to the average homeowner and don't impact your day-to-day use of the water or sewer systems; they do, however, make the systems more reliable in the long run. But there are many more projects that need to be accomplished.

The City is currently updating its water and wastewater system master plans. These plans, which are more than ten years old, identify and prioritize improvements needed in the distribution and collection systems, including improvements needed for growth as well as to simply maintain the existing system. We expect the master plans to be complete around January and, once completed, we will update our fee schedules and set about completing the highest priority projects. Funding for these projects is a challenge. While developers pay for impacts on the system created by the new development, maintenance of older water and wastewater systems falls primarily on the rate payer. We will need to be sure our new user rate structure includes the funding needed to bring these up to date. We also use grants whenever we can find them. Sorry so long! It's a complex subject.

Cori: I'm not entirely sure I understand your first question, but I think you are referring to the slurry seal we did a year or so ago on many of the newer streets. The slurry is a maintenance effort intended to prolong the life of streets so we don't have to reconstruct them so soon. We did subsequently find and repair a couple water service leaks in your area, and that did mean cutting into the street. We try to avoid cutting into nice new street, but leaks do happen from time to time.

City Manager Dana Shigley from City of American Canyon

Clancy:

Composting: Right now you are able to put only yard waste in your compost barrel. Our franchise agreement with Recology calls for them to implement food waste composting and they have obtained their state permits to do so. They are working out the details. I anticipate they will implement food waste composting in the coming year, but don't have any specific dates. Please feel free to call Recology if you want details.

Leashed dogs: We do have leash laws that cover all public trails and open spaces. We do this to ensure safety for our residents. While some people have very nice and obedient dogs, many dogs are hard to control. The laws are difficult to enforce. By the time we get someone out there, usually the dog and owner are gone. Of course, if you ever feel like you are in a dangerous situation, please call the police immediately.

Re leashed dogs. With all due respect that is a cookie cutter answer and we need resolution when people continually disregard the law. When I asked one woman several times on many occasions to please leash her dogs I was told to unleash mine! The police occasionally circle the parking lot but no one patrols the trails. Also, hunters access the Wetlands from the trails even though that is posted No Hunting and No Access to Hunting. Hunters are working on a blind close to Glass Beach that was accessed from the trail and not from the water.

Clancy- some good points. I asked Dana the question, as that's fundamental to understanding the answer. What she said is pretty much universal with leash laws. I have two tiny little dogs that I wouldn't let off leash for THIER safety. But others that unleash their dogs lack control necessary to stop a dog attack and certainly might not even know where their dog left a pile that needs cleaning up. So this becomes an issue of enforcement. Now that we've established why this law is in place in that area, the question then becomes why is it lacking enforcement and who would be the enforcers? Under normal circumstances, it's not something you'd call 911 over. It doesn't even seem like a job that the police should give any priority to. So the question remains. Perhaps we can all help with video (everyone has a phone) and lodging complaints? Dana- what do you think about this?

Jerry: The extension of Commerce to Wetlands will depend on development in the area. As the vacant parcels near Commerce develop, they will be required to create the connection. The connection is included in the City's general plan. We are very sensitive, however, to residents in the Wetlands area and need to be sure that the extension in done in a way to not increase traffic substantially. We don't have any specific timeline...depends on development proposals.

As for Newell to Main... do you mean punching Newell through west to the highway via Napa Junction, South Napa Junction or other street? These extensions are being studied as part of the Watson Ranch project.

City Manager Dana Shigley from City of American Canyon

Jerry: regarding green lawns in the parks: the lawns you see green are watered with recycled water, not potable water. The parks that are not so green are not yet connected to recycled water. We are currently in the process of converting Shenandoah, Silver Oak, and Tower parks to recycled water. They should get greener after the recycled water is installed. Community Park I and II conversions are more expensive, and longer term, projects.

Gary D: I assume you are referring to the new apartments at Napa Junction III? There are 148 units, not 600, and they need 40 acre feet of water per year. The Council has adopted a "Zero Water Footprint" ordinance that requires new development to offset every drop of new potable water demand by cutting water use elsewhere. The Napa Junction III developer is installing a recycled water line to the entire Napa Junction area, so we can convert Main Street park and all the landscaping to recycled water. The elimination of potable water for landscaping in Napa Junction more than offsets the demand by the apartments.
