**CALL TO ORDER AND WELCOME**

Zilke called the meeting to order at 4:07 pm. Gilbert formally announced her resignation due to her move to Oregon.

### **Redistricting Presentation**

RESA of Berrien Springs will host on September 24. Zilke stated that the Berrien Springs/Eau Claire Rotary Club was interested in co-sponsoring. The Michigan League requires an attendance form be filled out as well as a handout be distributed. The presentation is property of the League of Women Voters Michigan and cannot be shared. LWVBCC will videotape. Promotion of the presentation has been published in the St. Joseph Herald-Palladium.

### **Dues Payments**

Zilke would like to make a special appeal for money for upcoming candidate forums. A draft letter will be put together by Zilke. Ripley will do a mail merge and talk with our new webmaster, Mike McCaffery, about PayPal use for dues and donations on the website. A convenience fee will be charged for using PayPal. We will continue actual mailings to all members.

### **October General Meeting**

Ennis gave an overview of the meeting on October 12 from 2-4 pm at the New Buffalo Public Library presented by Elvin Gonzalez. His topic will be the schools to prison pipeline. Bickett suggested we remind attendees of other things the League does and ask them to get involved as well as ask for future topic suggestions. Further discussion brought up new member mentoring. Zilke suggested we pair a Board member with each new member joining.

### **Co-President**

Zilke again asked for members to step up to be a co-president for fiscal year 2016-17 and to assume the presidency thereafter.

## **Benton Harbor Mayoral Debate**

Lackner met with Charles Jennings and Larry Feldman at the NAACP office in Benton Harbor. They are tentatively looking at October 28 or 29 for the debate with the venue being either the Citadel, the Benton Harbor Public Library or the First Presbyterian Church. Discussion ensued about costs of venues and time frame of debate. One and one-half hours was thought to be enough time. A moderator was suggested by the NAACP. Topic questions need to be formed. Bickett stated we needed to be concerned about potential “gotcha” questions. Cards will be available for audience members to write questions for the candidates. The cards will be collected and edited/coordinated by League members and handed to the moderator at the end of the formal question period. Gilbert suggested a small committee of four determine the quality and quantity of questions — two from the League and two from NAACP. Lackner was directed to previous debates by LWV online for direction. A League member and/or NAACP member will welcome those in attendance and set the scene for the debate. A script with the rules (which is available) should be given to NAACP prior to the debate. It was noted that the moderator cannot change the script. Lackner will set up a meeting with NAACP within a week to go over these concerns. She will let Zilke know the outcome.

## **LWVLMR Convention**

Zilke and Dutton are registered for the September 25/26 convention. The cost is \$95, which has been paid. Ripley requested they give him an invoice for reimbursement.

## **December Social**

Ripley needs paperwork to make out a check for the deposit. Dutton will find out. The rental is \$65 and the cleaning fee is \$100. Zilke reiterated that we will pay for cleaning. Ripley suggested that if a member attends and gives a check for their dues to please give the check to Ripley immediately.

## **Roster/Membership Brochure**

Bickett is working on it. The issue was that it does not fit into a #10 envelope. He may donate an envelope and incorporate the existing pieces. Fifteen to twenty envelopes are needed per year.

## **DIRECTORS REPORTS**

### **COMMUNICATIONS**

A potential new person to do the Newsletters using Constant Contact has not responded after communication with her. There are ten issues (no August or February) per year with prepaid sponsorships. Gilbert noted that there should be a central person to coordinate the articles, communicate with the webmaster, update the calendar, etc. Ennis suggested someone who might be interested in putting together the Newsletter (but not writing the material) and will contact the person and ask if they would like to volunteer their services. Zilke suggested that if the person did a good job and liked doing it, perhaps we could consider paying them. Gilbert also suggested doing an e-Blast regarding our upcoming presentations/gatherings. Bickett will put it together and send out.

### **EDUCATION**

Ennis reported that Michigan's teacher evaluation program is still being considered. It is expected that the legislature will determine new rules legislation this Fall. On another note, it appears that a teacher shortage is being felt across the nation. Indiana's governor has called for a study to determine reasons for this.
