State of the Industry

- Ammo Shortages
 - Began 2012 due to high demand
 - Demand created by Aurora, CO. shooting, Presidential Elections, Newtown, CT. shooting
 - Almost back to normal now
 - Still somewhat difficult are all .22 caliber & odd-ball rifle cartridges
- Open Carry Law
 - New law goes into effect January 1, 2016
 - Must be a CHL holder
 - Must be carried on a shoulder or belt holster

- Investment Guns
 - Purchasing of firearm collections has been on the rise in recent years
 - Increases in value
 - Safer investment than stock market and other commodities now

Insurance & Appraisals

- Insurance
 - Home Owner Policies
 - Typically covered as personal property
 - Subject to a sublimit value (can range from \$500 to \$2,500)
 - Make sure covered by theft, loss & destruction
 - Obtain an additional rider policy or a stand-alone policy
 - Core-Venn, Farm Bureau
- Appraisals & Estate Planning
 - Some are required by insurance companies
 - Very good to have & to update regularly
 - Keep copies in at least two locations

Hunting with Sound Suppressors

- Now legal to hunt game animals with a sound suppressor
- Aids in ranch/land management
 - Hunting varmints
 - Game animals
 - Predator control
- Easy to own
 - Living trust
 - Product
 - Tax Stamp
