◆ **WARRANTS ISSUED FOR EX-BOYFRIEND**

A Cartersville man faces many charges after an incident at a motel on Highway 20, Tuesday. The victim said David Brandon Howell, 35, pointed a gun at him and his friend while they were in his car leaving the motel. The victim said David is his ex-boyfriend who he tried to separate from due to his aggressive behavior. The victim said David has been harassing him through text and e-mails causing him to fear for his safety. Howell will be charged with aggravated assault, stalking and pointing a gun/pistol at another.

◆ **TRACTOR STOLEN**

Bartow Sheriff's Deputies were called to Georgia Power-Plant Bowen, Covered Bridge Rd., after a theft. A Kubota R.T.V. was taken from the work site. The Kubota is worth over \$16,000.

◆ **BATTLES RECEIVES LEADERSHIP AWARD**

TOP NEWS

◆ Former State Representative Jeff Lewis has been reelected to the State Transportation Board by a caucus of state representatives and senators from the 11th Congressional District comprised of Bartow, Cherokee, Cobb and Fulton counties. He starts his second term in April, 2016. He was first elected to the board in 2011.

◆ U.S. District Judge Amy Totenberg ordered former state Rep. Tyrone Brooks to pay \$250,000 in restitution to charitable donors he's accused of deliberately defrauding. Brooks pleaded guilty in April to one count of filing a false tax document and no contest to five counts of mail and wire fraud. In November, Brooks was sentenced to serve a year and a day in prison. His prison term is to be followed by two years of supervised release plus 250 hours of community service.

◆ The CEO of Union General Hospital, Blairsville, was taken into custody Thursday along with 4 other hospital employees and one former employee. Dr. Michael Gowder is charged with 36 counts of fraudulently obtaining a controlled substance, 7 counts of unauthorized distribution and dispensing controlled substances.

◆ The founder and leader of Earth, Wind & Fire has died. Maurice White, 74, died at home in Los Angeles on Wednesday.
