FINAL EXAM PREPARATION

Students will be required to be on time for exams. Students late in excess of 15 minutes for an exam will not be permitted to take that exam and will need to reschedule and pay fees as noted below.

A \$50.00 fee will be charged for the administration of each exam not taken during regularly scheduled exam times. Checks should be made out to SCS and turned in to the business office prior to taking the exam. Odyssey team members advancing to the World Competition will not incur the \$50 fee.

Students who have 3 core subjects on Tuesday may opt to take their first scheduled exam another day after school. See Mrs. Schwartz on or before **Wednesday May 11th** to schedule an appointment.

OPEN CAMPUS DURING FINAL EXAMS

Terms and Conditions: "Open Campus" is defined as a 9 through 12 grade privilege to leave the Sarasota Christian School campus during final exam days when the student is not scheduled to take a final exam. Students who have a signed parental permission form on file with the high school principal may check out at the gate with the attending faculty member. Students without permission will have a supervised study hall they must attend when not taking an exam or during the scheduled lunch/time. Parental permission forms must be turned in to the high school administrative assistant at **least two school days before final exams begin**. It is the student's

responsibility to return to school on time for his or her scheduled exam. Also, transporting any SCS student off campus without parental permission is a serious offense and may result in the loss of this privilege in subsequent years at Sarasota Christian School.

Waiver of Liability: when the student and parent sign the Open Campus agreement, they agree to release Sarasota Christian School from any and all liability for a student's actions during his or her exercise of the Open Campus privilege. Furthermore, the signed agreement also releases Sarasota Christian School for any personal injury or loss of life while the student is exercising his or her Open Campus privilege. It is expressly understood that, once the student leaves the Sarasota Christian School campus, SCS will have no further responsibility whatsoever for that student nor his/her actions.
