The WCC selects sites based upon the course and stock combinations available, budgetary considerations, thoroughness of the proposal, distribution of the Regional sites across the country, likelihood of entries, and expanding herding opportunities into new areas. The WCC may ask questions of, request additional information from, or ask for modification to the bid from any or all bidders prior to making its selections.
