Southeast VT BBF Regional Council Notes June 8, 2016, 4-6 PM; Winston Prouty

Welcome and introductions

People introduced themselves and Chad introduced BBF statewide and our council.

Early Childhood Policy (with Matt Levin from the Early Childhood Alliance)

They are a coalition with a legislative agenda and provide support and advocacy around the state. The Coalition includes individuals and organizations. Each fall, they develop a legislative agenda that the EC community creates and works together on; it is not a prioritization of needs in the state. Throughout the year, they provide support for people to advocate with the legislature and in communities for young children and families. Matt shared a Legislative Summary for the 2016 Session. For each issue, there is a lead agency that is the point for each issue that can dig into the details. Overall, it was a difficult legislative session in terms of the limited resources.

- For CCFAP, they increased the funding by \$1 Million. Level funding would have likely resulted in cuts because the program is designed to grow. As providers get more STARs, their CCFAP reimbursement goes up, so the costs grow. The funding is also based on old FPL rates and market rates. The money will increase the market rates. There will also be a report to the Legislature in the middle of the year about the fiscal pressures. The lead organizations were VAEYC, VACCRA, VCCPA and LGK.
- The Paid Sick Days bill passed the legislature early in the session. It happened to be EC Day at the Legislature, which was a nice coincidence.
- The VT Affordable Housing Coalition was the lead on Affording Housing and Reducing Homelessness. This was the first year the Alliance was part of discussions about housing and homelessness. We have a lot to learn to make that discussion even more meaningful in the future.
- In terms of the FY 17 budget, there were additions to the child protection staff in AHS and in the Judiciary. In Brattleboro, we will be hiring new staff in DCF FSD, including a substance abuse screener and counselor who will be right in the DCF FSD office for families to access.

- Equal access to Special Ed Services is not a legislative issue. Once a child is screened and is in need of Special Ed services, it can be difficult for a child to access those services if they are going to an Early Learning center or provider out of the SU. There was not a resolution, but the conversation has started.
- VT Afterschool and summer learning were very successful in having conversations with legislators, but there was no additional funding allocated. This will likely be at the top of the list next year. People understand the importance of these programs for working families.
- Another non-legislative issue was the Building Bright Spaces for Bright Futures
 Fund. That fund provides loans for capital improvement to ELCs. It needs to be
 revitalized.
- Although investing in IT and integrated eligibility is not very glamorous, it is very important. AHS and other partners have updated systems. Right now, there is a 90% match from the Federal government. It is now broken into two phases that will move us to integrated eligibility.

There were some smaller issues, for example, revising the mandatory reporter language. The new language is now confusing for reporters. It will be revisited by the Child Protection Oversight Committee. The Dental Therapist designation passed. The Dr. Dynasuar expansion analysis is in process.

On an anecdotal note, Matt said he felt like people were really connecting with each other and with legislators. The stage is well set for next session.

In the next legislative session, there are about 20 issues on their radar. Not all of them are public yet.

- Funding needs: CIS, Autism, PCCs, CCFAP, all of the RTT-ELC initiatives, IT, Farm to School
- Dr. Dynasaur 2.0
- Public Pre-K funding
- Mandatory Reporter Language
- New CC regulations

The most important thing is how individual people or organizations can engage. It is almost impossible for an issue to come from the regional level to get through into legislation (example of success: Gilfeather Turnip). We need to figure out how to have local communities be the start of the cycle and circle the state. To be successful, it has to be an issue statewide. That is why there is an application process for putting issues on the legislative agenda. Almost always, the lead organization is a statewide entity. The Alliance does not want to impose ideas that are not relevant to local communities.

What we can do is build a network of support for local issues on a statewide level and then reach out to statewide organizations. The Alliance will help communities bridge to those statewide organizations with influence. Matt encouraged people/organizations to contact him or Kelly Ault first to figure out how to proceed; once there is a little bit of research, they can help lead us to an appropriate statewide organization. Even through BBF is not an advocacy organization, some of the issues that come up at BBF are the kind that we can forward to the Alliance through Chad.

Council Business: Announcements and updates

LGK

With BBF, VDH and other partners, LGK has released new data about child care affordability and availability in VT, <u>Stalled at the Start.</u> The report has gotten a lot of press in the state and it is generating a lot of momentum. Vicky is in the process of scheduling a meeting in Brattleboro to present the information and their polling research about people's perceptions of the importance of EC.

They will also be doing voter registration and education this summer/fall. A lot of people who care about kids and EC are not voting. They will be talking about that at the action team meeting; we may want to look at VT Adult Learning as a partner. She has been training volunteers, but if anyone is going to an event and wants to take LGK materials this summer, let her know.

LGK is hearing a lot about the new regulations, STARs and professional development from providers; they will be having some conversations across the state to talk about the costs of the new regulations.
