# **CALL TO ORDER**

• Chair Ruth Evans called the meeting to order at 12:10 p.m. With fewer than half the GAC present, Ruth explained that the meeting would proceed and recommendations for action would go to the Executive Board for final decision.

#### **ISSUE PRESENTATION**

#### A. Californians for Affordable & Reliable Energy (CARE) Project

Alison MacLeod of KP Public Affairs spoke about a coalition of organizations, businesses and Chambers that are concerned with the volume of climate change legislation. She pointed out the roughly 65 existing laws that deal with electricity mandates and emission reductions, and their unknown impacts on the economy. The CARE coalition is highlighting the fact that California doesn't have a long-term energy plan and one that analyzes the economic impacts of climate change legislation should be developed before more laws are passed. Some of the negative impacts of current laws are being seen in the manufacturing and construction industries. There is room for growth in green jobs, but not enough to offset the jobs lost in other industries.

Brian Domingos made a motion to recommend joining the CARE coalition. Victoria Salisch seconded the motion and the vote was unanimous.

#### L. SB 32 (Pavley) Global Warming Solutions Act of 2006: emissions limit oppose

### M. SB 350 (De Leon) Clean Energy and Pollution Reduction Act of 2015 oppose

# N. AB 67 (Gonzalez) Double Pay on the Holiday Act of 2015 oppose

Brian Domingos made a motion to recommend opposing this bill. Sieg Fischer seconded the motion and it passed unanimously.
