Trustee Bustos seconded the motion. Chairman Bennion called for a vote: Trustee Bustos and Trustee Corker voted aye. Trustee Freund, Chairman Bennion and Trustee Clayton voted nay. Motion failed 3-2...

Trustee Clayton made a motion to deny Syringa Mountain School's request to become an Innovative School. Trustee Freund seconded the motion. Trustee Clayton, Trustee Bennion, and Trustee Freund voted aye. Trustee Bustos and Trustee Corker voted nay. Motion passed 3-2.
