4. A historic drama of the famous 1839 slave ship uprising, a portrayal of antebellum America coming to grips with slavery—and how the law was employed both for and against (1997)
6. Gambini is representing his cousin and a friend—two California-bound college students who are arrested for capital murder after a short stop at a convenience store in rural Alabama (1992)
7. A lone juror expresses his doubts about what seems at first an open-and-shut prosecution (1957)
10. Film adaptation of a highly successful musical, celebrity murderers cynically parlay their Jazz Age notoriety into a vaudeville act. (2002)
13. In 1924, Chicago is rocked by a spectacular murder, apparently committed by two brilliant teenagers from wealthy families who have sought to plot and execute the perfect crime. An aging legendary lawyer is hired to defend the young men with the modest hope of sparing them from the gallows. (1959)

20. A Tudor-era judge made chancellor of England is caught in the political struggle involving Henry VIII’s decision to defy the Roman Catholic Church and divorce his wife to wed Anne Boleyn (1966)
22. A top-notch prosecutor who finds himself accused of murdering a colleague with whom he’s had an affair (1990)
23. A father and son falsely accused of participating in two separate IRA bombing spree outside London. The film chronicles their struggle to convince British courts of their innocence. (1993)
24. The story of three Australian countrymen who fight for the British Empire in the colonial Boer War in South Africa and are tried and convicted of war crimes (1980)

1. Atticus Finch rises above the naked racism of Depression-era Alabama to defend a crippled black man (1962)
2. A searing portrayal of the Nazi war crimes trials set in 1948, in particular, on charges brought against four German judges who are accused of allowing their courts to become accomplices to Nazi atrocities (1961)
3. Realistic study of an Army lieutenant accused of murdering a bartender who allegedly raped his coquettish wife (1959)
5. A first-year law student is desperately seeking the approval of Harvard’s sternest professor, only to discover that the young woman he’s involved with is the professor’s daughter (1973)
8. A newly minted lawyer, manages to quell a lynch mob by telling them he needs the two brothers accused in the murder to be his first real clients (1939)
