1.0 Chairman's Address

Bill Bessho, President of CITAP, welcomed the audience to the 18^h Annual General Meeting, the second AGM CITAP has held its AGM outside of Lower Mainland in an effort to bring AGM, CITAP presence, to across Canada to fulfill its mandate as a national organization. Cheryl reported to the membership that the newly required transition, adhering to Canada Non-for-Profit Corporations Act, had successfully completed with the membership approval of the new Bylaws in summer of 2014 and subsequent acceptance of our application to Corporations Canada in October of 2014. The process of reviewing the Bylaws to adhere to the new Act provided an opportunity to revisit the bylaw change, last of which took place in December of 2005.
