THESE ARE THE 2 SENTENCES WE NEED ADDED TO THE FARRM BILL.

These 2 sentences will conserve over 25 Billion Gllons of Water Per Year !

Notwithstanding any other provision of law, the Secretary of Agriculture shall require the use of water saving devices for hand washing stations and bathroom faucets at animal processing facilities inspected by USDA.

Such devices shall automatically shut-off the water flow when hands are moved out of the water stream and shall be proven to reduce cross-contamination caused by touching faucet handles.
