## **HOLD HARMLESS AGREEMENT**

I, \_\_\_\_\_, agree to and do hereby indemnify and hold harmless the Las Virgenes Unified School District, its officers, agents, and employees from every claim or demand made, and every liability, loss, damage, or expense, of any nature whatsoever, which may be incurred by reason of:

- A. Liability for damages for: (1) death or bodily injury to persons, (2) injury to loss or theft of property, or (3) any other loss, damage or expense arising under either (1) or (2) above, sustained by the undersigned or any person, firm or corporation employed by the undersigned upon or in connection with the activity called for in this Agreement except for liability resulting from the sole negligence or willful misconduct of the District, its officers, employees, agents or independent contractors who are directly employed by the District.
- B. Any injury to or death of persons or damage to property caused by any act, neglect, default or omission of the undersigned, or any person, firm, or corporation employed by the undersigned, either directly or by independent contract, including all damages due to loss or theft sustained by any person, firm or corporation, including the District arising out of, or in any way connected with the activity covered by this Agreement, whether said injury or damage occurs either on or of school district property, if the liability arose from the negligent or willful misconduct of anyone employed by the undersigned, either directly or by independent contract.
- C. The undersigned at his/her own expense, cost and risk, shall defend any and all actions, suites or other proceedings that may be brought or instituted against the District, its officers, agents, or employees, on any such claim, demand or liability and shall pay or satisfy any judgment that may be rendered against the District, its officers, agents or employees in any action, suit or other proceedings as a result thereof.
