This year Calabasas High's top Jazz Band was also selected. It is amazing that three of the twelve bands selected from the blind audition recordings are from the LVUSD! Both AHS bands and the CHS jazz band will perform at AHS's Celebrity Jazz Concert featuring David Berger and Ron Stout on Saturday, February 20th at 7:00 pm in the Agoura PAEC. Our Booster group will be working with the CHS Music Boosters to host a fabulous evening of Jazz. Please come out and support these groups.

Next month, both Orchestras will have a Master Class and perform with the New West Symphony at the PAEC on February 27th at 7:00 pm. In March, both choirs will have a clinic and perform with the Los Robles Master Chorale on March 20th at 4:00 pm in the PAEC. A group of Wind Ensemble students will be travelling to Chicago to take part in the Peary Grainger Festival March 10-13. They will tour the University of Chicago and Northwestern and attend the Chicago Symphony. In addition, all classical groups will be performing in the Spring Classical Concert on March 16th at 7:00 in the PAEC.

SAT/ACT Testing, Liz Cangelosi

We have had 148 enrolled students for the combined classes at Agoura High School this year.

This is up from 125 in 2014/2015 and 103 from 2013/2014. In the past 6 school years, our highest attendance was 159, so we are still drawing in a steady group. Total income has not been calculated yet but estimate about \$3500.

Due to the fact that so many classes and mock tests are offered online for free, we did drop our mock test rate to match the others in the local area, however I recommend we raise that price for 2016/2017 to cover online payment fee.

We will be scheduling classes for 2016/2017 shortly and we are in need of volunteers to assist with this program. This job can be done by a few people together and the work involved includes:

Scheduling dates with test prep company and determining prices

Working with test prep company to create two-sided flyer for registration day

Scheduling classrooms with AHS and LVUSD Facilities and sending follow up emails prior to each class to confirm

Entering class offerings in Pay4School site and on AHS PFC website

Running rosters from Pay4School web site prior to each class and submitting to test prep company

Submitting info to e-blasts and Acorn to advertise the classes, approximately one month to two weeks in advance of class/test

Most of this work is done off campus and per your schedule. Most of the work is done prior to school starting. Please let Liz Cangelosi know if you are interested in helping on this important resource that PFC provides to AHS students.

I. AHS Administrator/Staff Reports.

- **Brian Mercer, Principal:**

- The CASP website is being set up by the State of California. Once it is up, individual students and teachers will be able to log on and see breakdown of test scores and identify areas of challenge. In the past, teachers could not see the specific areas of success or challenge for students.
- Showcase Night is an in-depth open house event held on Wednesday, February 10, 2016 to connect with incoming freshmen and new students, and for current students to connect and plan for the coming year. Incoming freshman meeting will be first @ 5:45 in the PAEC. Junior meeting will be held simultaneously in G Bldg. Showcase will begin at 6:30 in the PAEC. Different campus groups and performs will present.
- Barbara McFarland is retiring at the end of the semester. AHS has hired a new English teacher who will be taking over starting on Tuesday for a trial semester.

- **Kristen Marsilio, Assistant Principal, Curriculum & Instruction:**

- Schedule changes will be visible over the long weekend so that students can begin in their new classes starting the first day of next semester on Tuesday, January 26.
- 11th grade students finished the first round of CASP practice testing in English and Math, and scores will be available for students and teachers to get a benchmark. One more round of practice testing will take place in February in preparation for April administration of the CASP. Teachers are finding students are well prepared for this new type of testing.
- Students will be meeting with counselors 1-on-1 in the spring to plan for next year's schedules, and parent drop-in dates will be publicized.
- IB information meeting will be held on January 27 @ 6:30 in PAEC.
- Parent Ed meeting last week on Cyber Education was one of most well-attended ever. AHS administration will be working to try to provide an opportunity for Lori Getz (www.Lorigetz.com) to return and talk with students. Administration is considering tying this into ongoing curriculum in social science classes.

- **Pat Brooks, Head Counselor:**

- Make sure your student's name on transcript matches birth certificate. Seniors are ordering 1st semester transcripts. Transcripts will be available by first week in February.

II. Co-President's Report. Co-Presidents Liz Cangelosi and Debbie Lopez welcomed attendees and presented the Co-President's Report:

- ACT and SAT prep courses are being held on campus in February and March with mock testing through Kaplan.

III. Guest Speakers. Penny Sylvester and Sharon Russell, Knowledge Counts Summer School:

- Summer School 2016 will be held at Calabasas High School. Semester 1 is June 14 – June 30 and Semester 2 is July 6 – July 21. First and last day of each summer school semester have mandatory attendance. Grading system is Endgrade, and grades must be entered daily by teachers so that students have immediate feedback. Knowledge Counts hopes to offer a trial class in college application essay writing. A flyer with details of cost, proposed classes, etc. is available.
- The cities of Westlake, Agoura Hills, and Calabasas will all run buses to Summer School. On-line summer school will not be offered through Knowledge Counts. Students should check with counselors to find out which online courses have been approved.

IV. Open Q&A.

- Rebeca Golden spoke about a “new driver” program that provides a sticker for cars with a number to call to report distracted teen drivers. Parents then receive the notifications so they can intervene with their teen. For each \$39 subscription, AHS will receive \$15.
- Question from a parent about how businesses acquire student email addresses. Mr. Mercer says he will follow up with administration to find out possible sources of distribution. Schools are not allowed to give any of that info out, but it can come from College Board, campus photography service, or other school-oriented sources.
- Question from a parent about school policy or expectations regarding frequency with which teachers update grades on Aeries. Mr. Mercer explained that teachers are expected to update Aeries at least every two weeks. If this is consistently not happening with a particular teacher, students should contact their counselor. Counselors and/or administration will get in touch with the teacher “anonymously” to remind them to update grades.
- Kids in Action is not allowed to continue at AHS under its current name due to liability exposure from students participating in overseas field trips.
- Fundraiser on January 29th for Theatre Arts boosters at the PAEC with screening of a movie for \$10.
