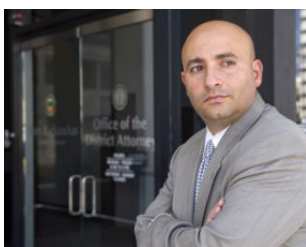
### THIS YEAR'S THREE HALL OF FAME INDUCTEES



#### THE HONORABLE MARIA D. HERNANDEZ

Maria D. Hernandez graduated from Western State in 1988. After practicing for 12 years at the Orange County Public Defender's Office, she was named Superior Court Commissioner. She was appointed Judge in 2009 where she supervised the Juvenile Drug Court and the Dependency Drug Court, and developed the innovative Boy's Court program. Judge Hernandez chaired the Commercially Sexually Exploited Children Task Force, and is a member of Chief Justice Cantil-Sakauye's Keeping Kids in School and Out of the Courts program, as well as the Judicial Council's Advisory Committee on Access to Justice. In 2014 Hernandez was named Presiding Judge of the Court's Juvenile Panel.

Judge Hernandez has lectured and taught widely including as a faculty member of the Judicial Counsel's Center for Judiciary Education and Research as well as serving as a long time adjunct faculty member at Western State. She was recently invited to join the Distinguished Fellows Program of the University of California Irvine's Center for Psychology and the Law.



#### EBRAHIM BAYTIEH

Ebrahim Baytieh graduated from Western State in 1996. He was born in Ghana and raised in Lebanon, and it was only in his late teens that the US became his home and English became his third language. From law school, he went directly to the Orange County District Attorney's Office, where he has become a star prosecutor.

Baytieh spent ten years on the department's elite Homicide Team, where he was named Assistant Head of Court. He is now Assistant District Attorney in Charge of Special Prosecutions. He has successfully tried more than 60 homicide cases and seven capital cases; he has been successful in strenuous and complex matters of public corruption.

In 2012, he was named Outstanding Prosecutor of the Year by the California District Attorney Association. In recognition of his skilled and eloquent prosecution of three white supremacist gang members for murder conspiracy, he was presented with the Helene and Joseph Sherwood Prize for Combating Hate by the Pacific Southwest Region Anti-Defamation League.

He lectures on a wide range of prosecutorial issues to prosecutors and law enforcement officers and officials throughout the country. He has frequently been called on to clarify important and timely prosecutorial and criminal matters before the citizenry.

#### VINCENT HOWARD

Vincent Howard graduated from Western State in 2003 and began his legal career with the Orange County District Attorney's Office. He moved to plaintiff's law with the firm of Lopez, Hodes, Restaino, Milman & Skikos, where he handled issues of mass tort litigation. He is now managing shareholder of his own firm in Anaheim emphasizing labor & employment, social security disability, workers' compensation and personal injury.

Howard came to the law from a distinguished career with the United States Army that included valiant service in Operation Desert Storm, for which he was presented with the Overseas Medal and the National Defense Ribbon.

He has developed a formidable leadership presence in a relatively swift career span. He sits on the Board of Governors of the Consumer Attorneys of California and the American Association of Justice; he has been selected among the top 100 lawyers of the National Black Lawyers; he is a member of the National Association of Distinguished Counsel as well as the Veterans' Legal Institute; he has been named a Super Lawyer from 2014-16. His hard work and generosity coalesced his year when the membership of the Orange County Trial Lawyers voted him in as President of their organization, one of the nation's most elite plaintiffs' bar associations.

### THIS YEAR'S HALL OF FAME LIFETIME ACHIEVEMENT AWARD RECIPIENT



#### **PEARL GONDRELLA MANN**

Pearl Gondrella Mann is Western State's second Lifetime Achievement Award recipient. She was inducted into Western State's Hall of Fame in 2000 primarily for her leadership achievements. Since her induction in 2000, time has only enhanced her place as one of the California legal community's most laudable leaders.

An AV Preeminent for legal ability and ethics, she has also shaped the direction of the bar through her presidencies of the California Women Lawyers Association, the Orange County Women Lawyers Association, and the Barristers, as well as her many committee chairmanships with the Orange County

Bar Association. She recently wrapped up her final eventful term with the State Bar Board of Trustees. Her advocacy for pro-bono services and for greater access to justice for the elderly, the poor and the disabled has earned her recognition throughout the State. She was named the Public Law Center's Attorney of the Year and was also presented with the State Bar's Wiley Manuel Pro Bono Award. These varied avenues toward improving the profession have most recently been recognized as this "ultimate volunteer" was selected to receive the OCBA's heralded Harmon Scoville Award.
